CHINA RMA ASSESSMENT OF NON-RVSM APPROVED AIRCRAFT

(Presented by China RMA)

SUMMARY

The China RMA conducts a monthly check of flight plan data against the combined global RVSM approval databases. This paper provides the outcome of the April 2015 check.

1. INTRODUCTION

- 1.1 From the beginning of 2012, China RMA started to provide evidence of non-approved operation through flight plan checks using monthly flight plan data and present results to the RMACG meeting.
- 1.2 This paper provides the results of once-a-month comparison between RMAs' approval databases and flight plans operated within the RVSM airspace of Chinese FIRs and Pyongyang FIR using the flight plan using the data up to April 2015.

2. DISCUSSION

- 2.1 A comparison is performed between the aircraft registrations seen in the monthly flight plan data available to the China RMA, and global approval database available on the KSN website. Only aircraft which flight planned into RVSM levels with a W in the equipment field were compared.
- 2.2 Experience had shown that the primary reason for failure to match operations and approvals was a delay in notification of the approval status of operators to the appropriate RMA, while there are also cases that the aircraft are confirmed to be non-approved or the approval has been expired.
- 2.3 The airframes suspected to be 'non-approved' for China and DPR Korea have been forwarded to the respective POC to confirm. Non-approved list of Chinese aircraft has been forwarded to the ATMB for follow up actions.
- 2.4 The China RMA also forwards data to other RMAs directly to confirm the approval status for suspected airframes. Some operator-aircraft combinations may stay in the 'to-be-confirmed' list for a couple of months.
- 2.5 **Attachment A** provides a list of suspected aircraft through monthly comparison between approval databases and flight plans. These aircraft are identified to have no RVSM approval registration, or have expired approval on their date of flight(s).

 - a) note and review the results of flight plan survey presented in this information paper;
 - b) cross-check the aircraft identified in **Attachment A** against their respective approvals database and confirm their approval status
