I have the honour to invite your administration to the Second Joint Meeting of the APIRG PBN and GNSS Task Forces which will be held at the ICAO Western and Central African Regional Office in Dakar, Senegal, from 2 to 4 March 2010.

The main objective of this Joint Meeting is to review the status of implementation of PBN and GNSS issues in the AFI region, and to take necessary action in preparation of the next ATS/AIS/SAR SG and APIRG meetings to be held in 2010. The various Working Groups established by the first Joint PBN/GNSS TF will also report to the meeting on their respective activities.

As you may be aware, there is a considerable amount of implementation work that is outstanding from various Conclusions and Decisions taken within the framework of APIRG, in particular since the last three PBN Task Force meetings. At the same time, this will be the second and last meeting of the PBN and GNSS/Implementation Task Forces before the forthcoming APIRG/17 meeting. In this context, it is essential that the meeting focuses on achieving progress on outstanding work, as opposed to developing new projects. It would be appreciated if your Administration would take this into consideration when developing contributions (working papers, etc.) for the meeting.

Kindly note that although this will be a joint meeting, there will be sessions in which experts in the PBN field and those in the GNSS field meet separately (in parallel) to address in-depth technical issues in each of these fields. As such, in deciding on participants to the above meeting, your Administration is urged to ensure the presence of expertise representing both fields. Furthermore, you are requested to include in the delegation, officials involved in the processes of aircraft/operator approvals for PBN related operations.

The draft Agenda for the meeting and explanatory notes thereto are at **Attachments** A and B, and the General Information Bulletin at **Attachment** C to this letter. The meeting will be conducted in English only.

Participants are urged to bring laptops and USBs/CDs as it is intended to hold this meeting with minimum papers. Presentations will be mainly on multi-media projections.

1. Organization, Site and Dates

3. Languages

The PBN and GNSS/I TFs meeting will be conducted in the English language only.

4. Opening session

The opening session of the meeting will take place on Tuesday, 02 March 2010 at 0900 hours. The meeting work schedule will be from 0900 to 1500 hours daily, subject to confirmation by the Meeting.

5. Registration

The registration of delegates/participants will take place at the meeting registration desk by the conference room on 2 March 2010 from 0800 hours.

6. Passport and VISA requirements

A VISA is required for citizens from Non ECOWAS countries. To this effect, the concerned delegates are kindly requested to complete the formalities in advance in order to obtain entry visas from the Senegalese Embassy in their Country, prior to departure.

Delegates who anticipate difficulties with the immigration procedures should contact the ICAO Western and Central African Office for assistance.

7. Exchange Rate

The currency used in Senegal is the Franc CFA (1US \$=454,578FCFA). The exchange of money should be made in banks or authorized places.

8. Transportation

The International airport of Léopold Sédar Senghor of Dakar is situated at about 15 km from downtown. Taxis are available at any time of the day. The charge is 5,000 FCFA from the airport to downtown at daytime and is posted at the arrival hall.

9. Health

A yellow fever vaccination certificate is mandatory. Visitors to Senegal arriving from cholera infected areas should have valid vaccination certificates.

10. Climate

The minimum temperature during the period is18°C and the maximum temperature is 24°C.

11. Lodging

A list of selected hotels in Dakar is enclosed. The hotel rates quoted are subject to confirmation when making reservations.
