Sir/Madam,

I have the honor to invite your Administration/Organization to the Third Meeting of the African Frequency Management Group (AFI/FMG/3) which will be held at the ICAO Regional Office in Nairobi, Kenya from 22 to 24 July 2013.

As indicated in its provisional agenda attached hereto, the AFI/FMG/3 meeting will, inter alia, evaluate the state of implementation of the conclusions and decisions of the second meeting of AFI/FMG, review the outcome of the ICAO 12<sup>th</sup> Air Navigation Conference pertaining to the area of aeronautical spectrum. The meeting will also examine the conclusions and decisions of APIRG/18 dealing with the subjects within the competence of the group and the recent activities and the future developments in the field of management and protection of the aeronautical frequencies spectrum.

The meeting will relay in particular, on the Final Acts of the ITU World Radiocommunication Conference held in Geneva during the first quarter of the year 2012 relating to the aeronautical spectrum and on the preparatory activities of the AFI region for the World Radiocommunication Conference envisaged to be held in Geneva from 2 to 27 November 2015. Finally, it will review and amend, if necessary, the Terms of Reference and the Future Work program of the AFI/FMG Group.

You will find also herewith, a general information bulletin with the list of hotels in Nairobi. In the meantime, be informed that the working notes prepared by the Secretariat will soon be available on the Web sites of the ICAO regional offices of Dakar and Nairobi and those sent by the various Administrations/Organizations will be posted as and when they are received.

For this purpose, the attention of your Administration/Organization is drawn on the need to actively participate in the AFI/FMG/3 meeting by preparing Working papers and producing necessary elements in relation to each item of the meeting agenda.
