6 GASP Goals

- 1. Achieve continuous reduction of ops safety risks
- 2. Strengthen States' safety oversight capabilities
- 3. Implement effective State safety programmes
- 4. Increase collaboration at regional level
- 5. Expand use of industry programmes & safety information sharing networks by service providers
- 6. Ensure appropriate infrastructure is available to support safe ops

T3.1	2023	All States to implement foundation of SSP

T3.3	2025/2028	All States to work towards effective SSP (present; present & effective)
T4.1	2023	States seek assistance
T4.2	2023	All Regions to publish RASP
T4.3	2025	All States to contribute information to RASGs
T5.1	Increasing trend	Industry's contribution in safety info sharing networks
T6.1	2025	States with AN and aerodrome infrastructure that meets ICAO standards



Standardized Frameworks

- Currently under development
 - Tool for organizing information
 - Direct data collection & analysis
- 3 Frameworks to support GASP/NASP
 - Identification of ORG Challenges
 - Selection (and removal) of G-HRCs
 - Drafting of GASP Goals, Targets & Indicators
- It defines:
 - Criteria Aspects / areas to analyse
 - Specifics Elements to analyse
 - Methodology Set of methods for analysis





Standardized Framework - ORG

- For identification of ORG challenges
- Focused on criteria:
 - Aviation system description
 - State's safety oversight capabilities
 - SSP implementation & maintenance
 - Common hazards & safety deficiencies
 - Breakdown by ICAO Region
 - min 5-year data set
 - Consideration of ORG challenges listed in GASP & RASPs





Standardized Framework – HRCs

- For identification of HRCs
 - criteria below may be used for inclusion & removal of occurrences
 - from G-, R-, N-HRC list
- Focused on criteria:
 - Fatality
 - Fatality risk
 - Number of accidents & incidents
 - Breakdown by ICAO Region
 - min 5-year data set
 - Consideration of G- & R- HRCs in setting N-HRCs
- Possible integration of contributing factors





Standardized Framework – G/T/Is

- Standardized Framework for Development of Goals, Targets and Indicators
 - in Aviation Safety Plans
- Addresses
 - Goals
 - Targets
 - Indicators
- Drafting criteria
- Specific points for consideration
