**EXPLANATORY NOTES ON THE AGENDA FOR APANPIRG/11****Agenda Item 1: Review of Council and ANC action on APANPIRG/10 Report**

The Group will review the actions taken by the ANC and Council on the Conclusions of APANPIRG/10 and may take note and/or propose further action. The Group will also review the progress made on all the Decisions and Conclusions of APANPIRG/10.

**Agenda Item 2: ASIA/PAC Air Navigation system and Related Activities****2.1 ATS/AIS/SAR Matters**

The Group will review the report of the ATS/AIS/SAR SG/10 meeting and propose actions as required. The Group will also discuss other ATS/AIS/SAR matters, if any, raised by the Members, States and the Secretariat.

**2.2 COM/MET Matters**

The Group will review the report of the COM/MET/NAV/SUR/SG/4 meeting and propose actions as required. The Group will also discuss other COM/MET/NAV/SUR matters, if any, raised by the Members, States and the Secretariat.

**2.3 ATS CO-ordination Groups' Activities**

Under this item the Group will review the results of the ATS Co-ordination Groups/Co-ordination meetings in ASIA/PAC Regions and note the progress made so far.

**2.4 Other Air Navigation Matters**

Under this item the Group will consider matters related to the Air Navigation Plans, air navigation services and facilities in the regions. In accordance with its Terms of Reference, the Group is expected to review the Statement of Basic Operational Requirements and Planning Criteria and recommend to the ANC any changes required in the light of new developments in the air navigation field. The Group will also review the report of the Asia and Pacific Area Traffic Forecasting Group and propose actions as may be required. In accordance with Conclusion 10/27, the ASIA/PAC Basic ANP and FASID have been updated and an amendment proposal to replace the existing ANP with the Basic ANP and FASID was circulated to States. The Group may wish to note the progress and propose further action as required.

Agenda Item 3:    **CNS/ATM Implementation and Related Activities**

Under this item, the Group will review the report of the CNS/ATM IC SG/7 meeting and propose actions as may be required. The Group will also review CNS/ATM related activities in the Asia/Pacific Regions as well as other regions.

Agenda Item 4:    **Shortcomings and Deficiencies in the Air Navigation Field**

The Group will review the list of Shortcomings and Deficiencies in the Air Navigation System in the region and propose an action plan with target dates for remedial measures. All provider and user States, IATA and IFALPA are requested to provide inputs to the Group.

Agenda Item 5:    **Review Outstanding Conclusions and Decisions**

The Group will review the progress made on all outstanding Conclusions and Decisions of its previous meetings and update the list of outstanding Conclusions and Decisions which are to be watched further.

Agenda Item 6:    **Develop Future Work Programme**

Under this item, the Group may wish to note that the ICAO Council had approved the Revised Terms of Reference of APANPIRG developed in APANPIRG/10 meeting. The Group is expected to develop its future work programme including those of the contributory bodies, the priorities to be assigned to its tasks and the future meeting programme. The Group will also review the report of the APANPIRG Sub-Group Programme Review Task Force and take appropriate actions on the recommendations of the Task Force.

Agenda Item 7:    **Any other business**

It may be recalled that Mr. Chen Xu Hua, designated Member from China was earlier elected as Second Vice-Chairman and had continued to serve in that position since the establishment of APANPIRG. China has advised that Mr. Chen Xu Hua has since retired from service. The Group needs to elect a new Second Vice-Chairman.

Other than the above item, the Group will consider any other matters not addressed in the preceding agenda items.
