**SUMMARY**

This working paper presents an action plan update proposal for the MEVA II / REDDIG interconnection implementation.

**1.      Background**

1.1            The Fifth Meeting of the GREPECAS ATM/CNS Subgroup CNS Committee, held in Lima, Peru from 13 to 17 November 2006, while reviewing the development and integration/interconnection status of the VSAT MEVA II and REDDIG and being informed of the actions being carried out by States, Territories and International Organizations Members of these networks, proposed that, in addition to a Memorandum of Understanding, it was necessary to prepare an action plan was necessary for the implementation of a technical configuration agreed for the interconnection, which should be implemented before the end of 2007.

1.2            The Fourth MEVA II / REDDIG Coordination Meeting (MR/4), held in Lima, Peru, from 7 to 9 March 2007, keeping in mind the CNS Committee Recommendation quoted in the previous paragraph, prepared an action plan for the interconnection implementation of the MEVA II and REDDIG VSAT digital networks.

1.3 The referred action plan groups, in a coordinated way, actions that each one of the parts of the MEVA II and REDDIG Parts involved agreed to carry out for the implementation and interconnection of both digital networks, including the description of each task, the responsible person and date of accomplishment of both digital networks, as well as comments. To this respect, during the Fourth Coordination Meeting MEVA II / REDDIG (MR/4) (7 to 9 March 2007), Conclusion 4/4 was formulated (*Adoption of the action plan for the MEVA II REDDIG interconnection*) so that States/Territories/International Organizations, MEVA II and REDDIG members directly involved in the networks, interconnection, as well as REDDIG Administration and the MEVA II Services Provider, adopt and carry out the corresponding tasks of the action plan, in such a way that same be performed prior to 30 November 2007.

1.4 The action plan for the MEVA II/REDDIG interconnection prepared by the MR/4 meeting was reviewed and amended by the GREPECAS/14 Meeting, held in San José, Costa Rica, from 16 to 20 April 2007, which results are presented in Appendix Z to the Report on Agenda Item 3 of the aforementioned Meeting. Consequently, GREPECAS formulated Conclusion 14/52 *Review for the adoption of the Memorandum of Understanding and implementation of the action plan for the MEVA II / REDDIG interconnection*, through which States/Territories/International Organization members of these networks were encouraged to approve and carry out the corresponding tasks of the Action Plan.

## 2. Analysis

2.1 In accordance with the information available to the Secretariat, the progress in the execution of the Action Plan for the MEVA II/REDDIG interconnection implementation, the RFP process, the acceptance and review of the MoU by the MEVA II/REDDIG members, and taking into account the replies to RFP that are being presented by the Service Provider of the MEVA II and the REDDIG Administration, **Appendix** of this working paper presents a proposal of the updated tentative action plan for the VSAT MEVA II/REDDIG network interconnection implementation.
