## Yesterday's meetings

## **First Meeting of the Executive Committee**

The Executive Committee opened its First Meeting in closed session at 0900 hours on Wednesday, 25 September and considered Agenda Item 10 (Contributions in arrears) on the basis of WP/43 Revision No. 1 (with Addendum No. 1), which provided information on, inter alia, the status of contributions in arrears and of Member States that had their voting privileges deemed suspended. In endorsing the action proposed, the Committee noted the progress made in the collection of long-outstanding arrears and approved the draft Resolution in Appendix D to WP/43 Revision No. 1 for submission to the Plenary for adoption.

### **Third Plenary Meeting**

The Third Plenary was held immediately following the First Meeting of the Executive Committee, which adjourned at 0920 hours. The Assembly approved the oral report presented by the Chairperson of the Executive Committee on the Committee's consideration of Agenda Item 10 (Contributions in arrears). The Chairperson thanked all those Member States that had paid their contributions on time and those that were making every effort not to be in arrears by concluding agreements with ICAO to settle their arrears. He urged those Member States that had thus far not paid their arrears or concluded such agreements for their settlement to do so as early as possible.

The remainder of the meeting was devoted to general statements under Agenda Item 8 delivered by the Delegations of: Libya, Nigeria, Burkina Faso, Indonesia, Singapore, Cuba, the Dominican Republic, Ethiopia, Japan, the Russian Federation, Colombia, India, South Africa, Portugal, the United Republic of Tanzania, Saint Kitts and Nevis, Saudi Arabia, Uganda and Yemen.

#### **Second Meeting of the Executive Committee**

At its Second Meeting, held on 25 September at 1400 hours, the Executive Committee considered Agenda Item 12 (Technical cooperation – Policy and activities on technical cooperation and assistance), documented in WP/19 [Revised (Spanish only)] presented by the Council, WP/171 [with Corrigendum No. 1 (Russian only)] (Indonesia), WP/334 (Japan) and information paper WP/134 [Interstate Aviation Committee (IAC)].

Agenda Item 18 (Cooperation with regional organizations and regional civil aviation bodies) was then discussed on the basis of WP/9 presented by the Council, WP/286 Revision No. 1 [22 Member States of the Latin American Civil Aviation Commission (LACAC)] and information paper WP/157 (Indonesia).

The Executive Committee next considered Agenda Item 19 (Duration of the terms of the Secretary General) based on WP/5 presented by the Council and approved the proposed updated Resolution appended thereto for submission to the Plenary for adoption.

Agenda Item 20 (Proposal to hold Assembly sessions every two years) was then discussed on the basis of WP/18 presented by the Council.

Under Agenda Item 21 (Proposal to amend Article 50 (a) of the Chicago Convention so as to increase the membership of the Council to 39), the Executive Committee reviewed WP/17 presented by the Council.

#### **First Meeting of the Economic Commission**

The Economic Commission, at its 1st meeting on Wednesday, 25 September at 1400 hours elected Col. Dokisime Gnama Latta (Togo) and Mr. H.M.C. Nimalsiri (Sri Lanka) as First and Second Vice-Chairmen respectively.

The Commission completed consideration, under Agenda Item 39, of the Annual Reports of the Council to the Assembly for 2010, 2011 and 2012 as well as the Supplement.

Under Agenda Item 40, Economic Development of Air Transport - Policy, the Commission considered the recommendations emanating from the Sixth Worldwide Air Transport Conference (ATConf/6) as well as other related subjects based on WPs 56 (Rev.1), 63, 73 (Rev. 3), 112, 185, 186 (Rev. 1), 188, 198, 202, 204, 290, 291, 293 and Information Paper 118. The Commission endorsed the recommendations adopted by the Sixth Worldwide Air Transport Conference (ATConf/6), as approved by the Council and presented in WP/56. The Commission also deferred the review of the Consolidated Statement in WP/55 until after the Commission has considered all relevant working papers presented

under Agenda Items 40 to 43, as each of the Agenda items, and the deliberations thereon, may impact the Commission's discussion relating to the Consolidated Statement.

The Commission then introduced Agenda Item 41 on Economic Regulation of International Air Transport on the basis of WPs 71, 187, 203 and IP 349 and will resume work on this agenda at its next meeting on Thursday, 26 September.

### First Meeting of the Legal Commission

The Legal Commission, at its first meeting on Wednesday, 25 September 2013, at 1400 hours, presided by its Chairperson, Ms. M. Gordon (Jamaica), elected Mr. S. Eid (Lebanon) and Ms. H. Hitula (Namibia) as its First and Second Vice-Chairpersons respectively.

The Commission completed consideration, under Agenda Item 45, of the Annual Reports of the Council to the Assembly for 2010, 2011 and 2012 as well as the Supplementary Report for the first half of 2013

Under Agenda Item 46 – The Commission considered the item "Acts or offences of concern to the international aviation community and not covered by existing air law instruments" on the basis of working papers A38-WPs 49, 109 and 154. The Commission noted the information therein and decided to: 1) call upon Member States to participate in the Diplomatic Conference to amend the Tokyo Convention; and 2) urge Member States to sign and ratify the Beijing Convention and the Beijing Protocol.
