I wish to inform you that the Third Meeting of the GREPECAS Programmes and Projects Review Committee (PPRC/3) will be convened at the ICAO NACC Regional Office in Mexico City, Mexico from 21 to 23 July 2015.

EXPLANATORY NOTES OF THE AGENDA FOR THIRD MEETING PPRC/3 MEETING

Agenda Item 1: Follow-up status on GREPECAS valid conclusions and decisions and "U" priority air navigation deficiencies in the CAR/SAM Regions

1.1 Review of the implementation status of the GREPECAS valid conclusions and decisions

Under this agenda item, the Meeting will review the implementation status of the conclusions and decisions formulated by the GREPECAS/17 held in Cochabamba, Bolivia (Plurinational State of), from 21 to 25 July 2014, and take the appropriate measures in this respect. On 28 January 2015, the conclusions and decisions of the GREPECAS/17 meeting were reviewed by the Working Group of the Whole for Strategic Review and Planning (AN-WG/SRP) of the Air Navigation Commission.

1.2 Status of "U" priority air navigation deficiencies in the CAR/SAM Regions

Under this agenda item, the Meeting will examine the current status of "U" priority air navigation deficiencies. Likewise, the Meeting follow-up on the application on the new methodology for the identification, assessment and reporting of air navigation deficiencies.

Agenda Item 2: Air navigation activities at global intra and inter-regional level

2.1 Result of the Second Planning and Implementation Regional Group (PIRG) and Regional Aviation Safety Groups (RASG) Global Coordination Meeting

Under this agenda item, the Meeting will examine the results of the Second Planning and Implementation Regional Groups (PIRGs) and Regional Aviation Safety Groups (RASGs) Coordination Meeting held in Montreal, Canada, on 5 February 2015, with the participation of the Secretaries, Presidents of the PIRGs and RASGs, the President of ICAO Council, the Secretary General and ICAO Air Navigation Bureau Director.

Likewise, the Meeting will be informed on the progress of the development of the new ICAO electronic Air Navigation Plan (e-ANP) and the follow-up to the development of the regional performance dashboard as well as the Air navigation annual report.

2.2 Follow-up to the implementation of intra and inter-regional activities

The Meeting will take note on the relevant implementation activities in air navigation in the States, Territories and International Organizations of the CAR/SAM Regions, as well as inter-regional activities between the CAR and SAM Regions and between the CAR and SAM Regions with other ICAO Regions regarding air navigation aspects.

2.3 RASG Coordination matters

The Meeting will take note of the activities developed by the RASG-PA since GREPECAS/17. Likewise, the Meeting will examine the GREPECAS-RASG cooperation mechanism as well as the interaction of these groups in favor of optimizing efforts to improve the safety and efficiency of operations, including the link of the RASG support to guide the GREPECAS on working together for the achievement of the priorities in safety so that they are considered in the planning of corresponding GREPECAS programmes and projects.
