1. Introduction

1.1 A special meeting of the Group for the continued improvement of ATS over the South Atlantic (SAT) member states¹, held in July 2021, approved a new structure and a new handbook, including Terms of References for the Steering Group (SAT SG), Implementation Management Group (SAT IMG) and Safety Oversight Group (SAT SOG). Brazil chairs the SAT SOG, and Trinidad and Tobago is the co-chair. Also, Regional monitoring agencies (RMA), industry, IATA and international organizations are members of SAT.

2. Analysis

The Steering Group - SAT SG

2.1 The SAT SG aims primarily to ensure with the support of its contributory bodies, a continuous, coherent and harmonized implementation of the air navigation system in the South Atlantic parties of the AFI and SAM Regions, in accordance with the provision and schedule of the concerned Regional Air Navigation Plans aligned with the Global Air Navigation Plan (GANP Doc. 9750). The SAT SG has convened its first meeting (virtual) for December 4th, 2023. The SAT SG/1 meeting draft agenda is shown in **Appendix A.**

Implementation Management group - SAT IMG

- 2.2 SAT Implementation Management Group (SAT IMG) is responsible to the SAT-SG for the identification, planning, development and coordinated implementation of safe and efficient project supporting the aviation system within the SAT Region.
- 2.3 With regards to requirements of the SAT region, SAT IMG, composed of multidisciplinary experts including both ATM and CNS experts, will address as a matter of priority, issues of capacity, procedures and interoperability related to EUR/SAM corridor and AORRA Airspace.
- 2.4 In order to efficiently achieve the tasks assigned by SAT-SG, SAT IMG may be assisted in its work, by contributory bodies as Ad hoc Groups, Project Teams or Implementation Teams charged with specific functions and/or tasks.
- 2.5 Up to date, SAT IMG group held two meetings, respectively, in Abidjan, Côte d'Ivoire, from 21 to 24 November 2022 (SAT IMG/01) and Paris, France, from 24 to 27 July 2023 (SAT IMG/02). In SAT IMG/02, matters were discussed, and the implementation of ATM/CNS was monitored, among other topics;
 - ✓ Planning and implementation programs. Review of EUR-SAM corridor implementation team (ESCIT) meeting outcomes
 - ✓ Airspace and ATS Route improvements
 - ✓ Contingency Plans
- 2.6 The SAT IMG/02 meeting Action Item List and approved Decisions are provided at Appendix B.

Safety Oversight Group - SAT SOG

- 2.7 The SAT SOG is responsible to the SAT-SG for:
 - a) monitoring safety management of air traffic service provision in the SAT Region and encouraging adoption of best practices;
 - b) ensuring the availability and correct categorization of SAT Region reported occurrences for the purposes of mathematical analysis and other safety management activities; and
 - providing statistical data and advices relating to monitoring of safety assessment and any other related tasks.
- 2.8 Regarding to the monitoring of safety management of ATS provision, the SAT SOG will:
 - a) Address safety related issues and system safety performance of the SAT Region through monthly/regular conference call and face to face meetings
 - b) Ensure that safety-related occurrences in the SAT region are reported and analyzed by the concerned party to determine root causes and trends;

- c) Promote SAT SOG skills and methods for addressing safety-related occurrences among stakeholders developed by SAT SOG and best practices;
- d) Ensure SAT airspace structure changes are covered by safety assessment approved by the concerned SAT Member State;
- e) In coordination with the SAT IMG, identify areas where mitigation is required.
- f) Assess the effectiveness of implemented mitigation measures;
- g) Develop and maintain SAT Safety Policy as well as safety monitoring methods and analysis in order to recommend improvements to the processes as appropriate to the SAT-SG;
- 2.9 The SAT SOG group held its first meeting in Miami, Florida, United States, from 13 to 17 March 2023. The following topics were addressed, among other:
 - ✓ Implementation of the Group's terms of reference. Work programme. Safety policies
 - ✓ Databases for RMA processes. Statistics.
 - ✓ Collision risk assessment and LHD. Harmonization of RMA processes.
 - ✓ Training
- 2.10The Action Item List, and approved Decisions are provided at **Appendix C.** The next SAT SOG/02 virtual meeting is scheduled for 27 29 November 2023.
- 2.11The second meeting (virtual), SAT SOG/02, will be executed from 23 to 29 November 2023. The draft Agenda is shown in **Appendix D**.

3. Conclusions

- 3.1 The Group for the continued improvement of ATS over the South Atlantic (SAT) and its contributing bodies, the SAT IMG and the SAT SOG, are promoting optimization of services and the strengthening of operational safety in said airspace, including the AORRA. Also, the SAT is focused on maintaining the harmonization of the implementations of advanced air navigation concepts with the adjacent NAT region.
- 3.2 Important to remark on the contribution of CAR/SAM Region states involved in the SAT operations, through their participation in the two working groups and the corresponding project teams. As well, the cooperative work of RMAs, as SATMA, CARSAMMA, NARMO and ARMA, for the harmonization of procedures and methods of safety assessment is highlighted.
- 3.3 The SAT receives very significant support from FAA, the Industry, IATA, CANSO, etc.
