African-FPP at a glance






Foster PBN implementation in Africa in accordance with Assembly Resolution A37-11 (PBN goals).

Operating concept:

- Assist African States/Organizations to address PANS-OPS related issues:
 - Development of in-house capability;
 - Focus on PBN flight procedures, quality assurance.
 - Development of instrument flight procedures;
 - Provide a vehicle to improve flight procedure design process through access au automated solutions.
- Source of the Programme budget (income):
 - Annual financial subscriptions (USD10 000/ year)
 - Tuition fees (non-active members);
 - Products and services (Design projects, etc.).







Programme sustainability challenges:

- Lack of financial resources as many active members don't pay their annual subscriptions; as a consequence:
 - Impossible to recruit the staff;
 - High rate of experts turnover;
 - Lack of automated aeronautical charting solution.
- PANS-OPS related shortcomings:
 - Absence or obsolete WGS-84 implementation;
 - Navaid periodic calibration;
 - Maintenance of the instrument and visual flight procedures;





□ PANS-OPS related shortcomings (ctd'):

- Inadequate PANS-OPS oversight system:
 - Insufficient legislation to address all PANS-OPS issues;
 - Practices differing from existing legislation;
 - Lack of PANS-OPS experts; and
 - Lack of expertise to oversee instrument flight procedure approvals.

□ As a result, (potential) Safety Significant Concerns (SSCs) reported following the ICAO USOAP CMA activities



Change in the Programme governance document:

- In order to ease its revisions and to align it with similar ICAO programmes, the Programme Document is now structured into two parts:
 - The Programme document (Prodoc) with an annex:
 - Prodoc is available for all participants right now or later right now or later.
 - The Management Service Agreement (MSA)
 - Programme members shall sign the MSA right now or later, to confirm their membership;
 - Prospective members can sign the MSA, right now or later.

- ^{CP} Fully comply with the ICAO recommendations on PBN (AR 37-11) and some of the ASBU modules (APTA-B0/4 (CDO), APTA-B0/5 (CCO) and APTA-B0/5 (PinS)).
