**Subject: Second Meeting of the African Frequency Management Group AFI/FMG/2  
(Dakar, Senegal 18-19 April 2011)**

***Required Action: To reply before 10<sup>th</sup> April 2011***

Sir/Madam,

I have the honor to invite your Administration/Organization to the Second Meeting of the African Frequency Management Group AFI/FMG/2 which will take place in the conference room of the Agence pour la Sécurité de l'Aviation Civile en Afrique et à Madagascar (ASECNA) located at 32-38 Avenue Jean Jaurès, Dakar, Senegal.

As indicated in the provisional agenda attached hereto, the AFI/FMG/2 meeting will evaluate, inter alia, the state of implementation of the conclusions and decisions of the first meeting of the Group (AFI/FMG/1), examine the conclusions and decisions of APIRG/17 dealing with the subjects within the competence of the group and examine the recent activities and the future developments in the field of the management and the protection of the aeronautical frequencies spectrum. For this reason, the meeting will focus in particular on the preparatory activities of AFI States for the World Radiocommunication Conference envisaged to be held in Geneva from 24 January to 17 February 2012. Finally, the meeting will review and amend, as appropriate, the Terms of Reference and the Future Work programme of the AFI/FMG.

This meeting would be followed by a seminar/workshop on the CMR 2012 and the challenges on the radioelectric frequencies spectrum scheduled by ASECNA from 20 to 22 April 2011. This seminar, which aims at reinforcing the internal capacities of the staff of ASECNA will be open to AFI air navigation service providers and ASECNA will confirm in due course its effective holding.
