Agenda Item 1: Adoption of the Draft Agenda

Agenda Item 2: RASG-AFI Terms of Reference and Organizational Structure

The Meeting will review the RASG-AFI detailed Terms of Reference for approval, review and approve the organizational structure and elect the Chairperson and Vice-Chairpersons, as well as the Steering Committee of the RASG-AFI. A review of the current sub-regional mechanisms will be done and means to integrate their activities within the RASG-AFI discussed.

Agenda Item 3: Global Aviation Safety Plan

Under this item, a presentation on the Global Safety Initiatives and future updates of the GASP will be given. An overview of the Safety Fund (SAFE), including the process followed for its establishment and the classification of contributions will be given. The Meeting will also discuss the possible projects and available resources to be considered by the RASG-AFI.

Agenda Item 4: Status of implementation of SP AFI-RAN Meeting Recommendations and follow-up

The status of implementation and follow-up of safety related SP AFI/08 RAN Meeting recommendations will be reviewed, in particular: Recommendations 3/2-ACIP Programme implementation, 4/4- ADREP/ECCAIRS implementation and 4/5-Establishment of Regional Accident Investigation Organizations. Initiatives relating to the Identification and Resolution of Significant Safety Concerns including the AFI-Cooperative Inspectorate Scheme project will also be reviewed.

The establishment of Regional Aviation Teams will be discussed. The status of implementation and follow-up of SP AFI/08 RAN Meeting recommendations will be reviewed, in particular: Recommendations 5/8-Training strategies for safety in Africa. The status of implementation of the COSCAP Programmes in the AFI Region and progress in the transition to Regional Safety Organizations will be reviewed.

Agenda Item 6: Other Safety initiatives and Regional organizations in the AFI Region

The meeting will be presented with Information Papers on safety initiatives and experiences of different existing sub-regional Organizations.

Agenda Item 7: Coordination between RASG-AFI and APIRG

The meeting will discuss the needed coordination between RASG-AFI and APIRG in order to ensure efficiency and non-duplication in addressing aviation safety issues.
