 - African State
 - Part of Programme Steering Committee
 - Commitment to funding the Programme with Annual financial contribution
 - May be waived through in-kind contribution under agreement by Steering Commitee
 - User States
 - African State
 - No commitment to funding the Programme; some free services, other services by service fee
 - Observer States
 - Participating State not necessarily African
 - No commitment to funding the Programme; services by service fee

 - each Active Participating States (APS); and
 - Host Administration (ASECNA)

Steering Commitee role and responsibilities

- Role and reponsibilities
 - Review & approve Annual work programme;
 - Review & approve Annual budget;
 - Review & approve Annual financial contribution for APS; and
 - Considering request for waiver of financial contribution in lieu of in-kind contribution

And,

- Review of Performance of Programme;
- Review of Programme document, as necessary; and
- In consultation with ICAO Policy,
 - Review and approve fee schedule for services and trainings

Conduct of the SC Meeting



AFI FPP

- Steering Committee (SC) meetings
 - At least once a year;
 - 2 Co-chairpersons, each from ESAF and WACAF area;
 - Co-chairpersons elected by Members of SC for duration of Phase I;
 - Minimum attendance:
 - At least 3 Members, including 1 co-chairperson and ICAO;
 - Upon agreement by the SC, attendance may include
 - Participants States;
 - Donors
 - guests to assist in achieving objectives of the Programme;
 - Will be conducted in the English Language;
 - If resources available, could be conducted in the French Language
 - AFI-FPP Manager is the Secretary of the SC

ICAO OVERSIGHT STRUCTURE



AFI FPP

- ICAO assistance to the Programme
 - provide financial account management;
 - budgetary control of the programme;
 - submit financial reports in accordance with its rules and procedures;
 - monitor implementation of the programme in collaboration of the Programme Manager;
 - Administrative and operational oversight
 - undertake monitoring missions.
 - provide technical support to its experts in the performance of their duties.

Reporting

- AFI-FPP Manager provides quarterly reports to ICAO ESAF and WACAF Regional Offices, ANB, TCB and to the SC via WACAF Regional Director;
- AFI-FPP Manager provide an Annual Report to the Steering Committee; and
- At least two months prior to the end of his assignment, the AFI-FPP Manager will submit a draft Terminal Report to ICAO WACAF RD.
