STATUS OF SADIS 2G IMPLEMENTATION BY ICAO REGION

(Presented by the SADIS Provider State)

SUMMARY

This information paper presents an overview of the status of SADIS 2G implementation according to ICAO Contracting States.

1. INTRODUCTION

1.1 In accordance with SADISOPSG Conclusion 9/15, the SADIS first generation (SADIS 1G) broadcast will continue until 31 December 2008. WP/17 of this meeting invites the group to consider the cessation date of SADIS 1G, based on a number of factors including implementation of SADIS 2G.

1.2 Since the implementation of the SADIS second generation (SADIS 2G) broadcast in 2004, all existing SADIS 1G users have been advised to consider upgrading their SADIS receiving equipment to accept SADIS 2G, and all prospective new satellite broadcast users have been advised to procure a SADIS 2G receiving system.

2. DISCUSSION

2.1 The Appendix to this information paper provides an overview of the status of SADIS 2G implementation according to ICAO Contracting States (by ICAO Region). The information is correct as at 03 March 2008.

2.2 The group will note that within the EUR region, 63% of Contracting States have users who are already operating SADIS 2G VSAT receiving equipment. Within the MID, AFI and ASIA regions, this figure is 56%, 29% and 43% respectively.

2.3 The results of the SADIS Operational Efficacy questionnaire (WP/9) indicate that the majority of States with users still accessing SADIS 1G will upgrade to a SADIS 2G receiving system before the end of 2008.

2.4 The SADIS Provider State will, in the near future, issue a SADIS administrative message on the broadcast to draw attention to the fact that SADIS 1G will terminate on 31 December 2008, and that users are encouraged to upgrade to a SADIS 2G receiving system as soon as possible. Reminder notices will be disseminated at regular intervals in the lead up the SADIS 1G termination.
