# **INTRODUCTION**

#### Place and duration

i.1 The Third Meeting of the SADIS Cost Recovery Administrative Group (SCRAG) was held, at the invitation of the UK Met Office, at the UK Met premises in Bracknell on 5 and 6 November 2002.

# Attendance

i.2 The Meeting was attended by three of the five Members of the Group and two of the three Observers. The list of participants is in **Appendix A** and a list of working papers issued for the Meeting is in **Appendix B**.

#### **Officers and Secretariat**

i.3 **Mr. L.J.N. Rolvink**, from the Netherlands, was Chairman of the Meeting. **Mr. J.C. Bugnet**, Chief, Joint Financing Section, ICAO Headquarters, Montreal, acted as Secretary of the Meeting, assisted by **Mr. B. Hellroth**, Regional Officer Meteorology/Aeronautical Information Services, of the European and North Atlantic Office of ICAO in Paris.

# Visit of the UK Met Facilities

i.5 The group visited the Satellite Earth Station at Whitehill and the National Meteorological Center in Bracknell, from where the SADIS services are provided.

# AGENDA ITEM 1: REVIEW OF SCRAG'S TERMS OF REFERENCE, COMPOSITION AND WORKING ARRANGEMENTS

1.1 The Group was informed that Mr. Lars Wedbäck had left the Swedish administration and consequently had to step down as Chairman of the SCRAG and as SCRAG member.

1.2 The Group noted that the Parties to the SADIS Agreement from the European Region still represent in the aggregate more than 50% of the total assessments, which results in the nomination of two SCRAG members from this Region, in accordance with Article VII, paragraph 2 of the SADIS Agreement.

1.3 The Group was informed that the European Air Navigation Planning Group (EANPG) had agreed that Germany should replace Sweden as member of the SCRAG and that the chairmanship should be taken over by the Netherlands. Germany had subsequently nominated Dr. Erland Lorenzen, and the current member from the Netherlands, Mr. L.J.N. Rolvink, had been nominated as the Chairman of the Group.

1.4 The Group was also informed that M. Ahmed Hesmath Abdel Kawy, from the Egyptian Civil Aviation Authority, was replacing Mr. Mohamed Muktar Mousa, who retired, as SCRAG member from the Middle East Region and that Messrs. Xu Jianliang, from China, Amadou Mamadou Watt, from Senegal, and Nicolas Zvenguintzoff, from IATA, apologized for not being able to participate in this meeting.

1.5 The Group expressed its sincere appreciation to Mr. Wedbäck for the outstanding job that he did steering the SCRAG Group through its first years of existence.

1.6 The Group noted its Terms of Reference assigned by Article VII of the SADIS Agreement, which reads:

"The SCAR arrangement shall be administered by a group, the SADIS Cost Recovery Administrative Group (SCRAG) which shall:

- a) assess the annual cost share attributable to each Party, including re-assessments arising from new Parties adhering to this Agreement; and
- b) audit the costs of the SADIS provision and any related financial activities, incurred by the provider State and subject to cost sharing."

1.7 The Group was informed that ICAO had received a formal notification of accession to the SADIS Agreement from 41 States, that 11 States had informed ICAO of their intention to accede to the SADIS Agreement but had not yet sent a formal notification of accession, that seven States had denied their accession to the SADIS Agreement, and that 31 other States receiving the SADIS service had not yet replied to the letter of the Secretary General of ICAO inviting the States receiving the SADIS service to accede to the SADIS Agreement. It was also informed that from these last 31 States, 18 are Least Developing Countries (LDCs), which are exempted from payment of SADIS cost share, and that the SADIS cost share for the year 2001 of 11 other ones had been paid. (See Appendix D).

# AGENDA ITEM 2: CONSIDERATION OF ISSUES RELEVANT TO THE SCRAG'S WORK ADDRESSED BY THE SADIS OPERATIONS GROUP (SADISOPSG)

2.1 The Group was informed of the main conclusions of the Seventh Meeting of the SADIS Operations Group (SADISOPSG/7, Cairo, 9 to 13 June 2002) provided by the Chairman of SADISOPSG in the Executive Summary of Discussions of this meeting.

2.2 The Group noted the Statement of SADIS operational efficacy received from the Chairman of SADISOPSG relaying the advice from the Group at its seventh meeting (SADISOPSG/7, Cairo, 9 to 13 June 2002) to SCRAG that the operational efficacy of the SADIS had continued to be satisfactorily meeting all operational requirements since the SADISOPSG/6 Meeting (Paris, 28 May to 1 June 2001).

2.3 The Group noted Conclusion 7/5 of SADISOPSG/7 instructing the Chairman of SADISOPSG to forward to the Chairman of SCRAG an updated SADIS Inventory. This proposal is dealt with under Agenda Item 5 (See below). The Group noted that SADISOPSG/7 agreed that there would be no need to carry on with the two-way programme beyond the life time of the current systems.

2.4 The Group noted Conclusion 7/16 of SADISOPSG/7 regarding the consequences of the switching off of SADIS receiving equipment, which reads:

"That the Chairman of the SADIS Operations Group inform the Chairman of SCRAG that the SADIS Operations Group expected that, in States where SADIS is switched off, it would be the responsibility of the State concerned to ensure that adequate alternative arrangements were made for obtaining the necessary data and products."

The Group also noted in this respect that both ICAO and the CAA of the United Kingdom had reminded in writing the responsibility mentioned above to the States concerned before withdrawing, in August 2002, the SADIS service to four States which had not paid their SADIS cost share for 2001.

# AGENDA ITEM 3: REVIEW OF ACTUAL SADIS COSTS AND COST SHARES FOR THE PERIOD 1 JANUARY TO 31 DECEMBER 2001

3.1 The Group reviewed the actual costs provided by the United Kingdom of providing the SADIS services in the year 2001. These actual costs are presented in **Appendix E** and total £ 509,058. A summary of these costs is presented in **Table 1**.

3.2 The Group noted that the increased costs for maintenance were due to renewal of the maintenance contract and rental of additional rack floor spacing at the Whitehill Station. The breakdown of maintenance costs for 2001 are as follows:  $\pounds 6,300$  (rental and electric supply to second SADIS communications rack at Whitehill),  $\pounds 31,746$  (on-going contracted maintenance support), and  $\pounds 5,860$  (non-routine repair of hub infrastructure equipment and technical management meetings). In 2002, the annual maintenance cost of  $\pounds 52,000$  comprises  $\pounds 40,500$  for fixed maintenance charge,  $\pounds 6,300$  for rental of additional rack floor spacing, and  $\pounds 5,200$  for repair of redundant equipment by Astrium.

3.3 The Group noted that three States, Brunei Darussalam, Namibia and Pakistan, which were assessed for the year 2001 by the SCRAG/1 Meeting, denied their accession to the SADIS Agreement. Therefore, these States were not considered in the final calculation of the shares of the actual costs for 2001.

3.4 The Group noted that one State, Malaysia, which was not assessed for the year 2001 by the SCRAG/1 Meeting, has been receiving the SADIS service during the period 1 January to 31 December 2001. A provisional cost share for 2001 has been invoiced for an amount of £18,941.81 on the basis of the number of available tonne-kilometres (ATKs) in scheduled services (international and domestic) in 1999 by air carriers based in the territory of this State, in accordance with Article XI, paragraph 1 of the SADIS Agreement. The Group was also informed that three States which had not been assessed for 2002 by the SCRAG/2 Meeting have been billed for the 2002 estimated cost shares calculated on the basis of their number of ATK's in 1999: Malaysia (£17,986.38), the Republic of Moldova (£63.51) and Thailand (£17,027.21). Corresponding payments have been received from the Republic of Moldova and Thailand but not from Malaysia. The necessary adjustments will be dealt with by the SCRAG/4 Meeting.

3.5 The Group determined the actual cost share for the period 1 January to 31 December 2001 to be borne by the States parties to the SADIS Agreement which are not exempted because they are on the list of the Least Developed Countries or because they denied their accession to the SADIS Agreement, on the basis of their number of ATKs in scheduled services for 2001, in accordance with Article XI, paragraph 3 of the SADIS Agreement. The cost share in percentage terms and the share in £ sterling to be borne by each State participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement are shown in **Appendix E**. Accordingly the Group formulated the following Conclusion:

Conclusion 3/1 -

The actual cost shares for 2001 as shown in Appendix E for the States participating in the SCAR Arrangement are approved by the SCRAG/3 Meeting, in view of the adjustments to be made by the CAA of the United Kingdom in its billing of these States.

3.6 The Group received information from the observer from the United Kingdom on the status of payment of the cost shares of 2001 as at 15 October 2002. It noted that 57 States of 63 States which were assessed for 2001 had paid their cost share (£461,087) representing 91.6% of the original assessments as approved by the SCRAG/1 Meeting.

3.7 The Group noted that, in accordance with the provisions of article XIII of the SADIS Agreement, the SADIS service had been withdrawn as of August 2002 to four States which had not paid their SADIS cost share for 2001 in spite of a number of reminders. Since then, the SADIS service has been reinstated to one of these States which has paid its 2001 arrears.

3.8 As mentioned in paragraph 3.3 above, three States which were assessed for the year 2001 by the SCRAG/1 Meeting have denied their accession to the SADIS Agreement after this meeting: Brunei Darussalam ( $\pounds$ 1,722.89), Namibia ( $\pounds$ 314.75) and Pakistan ( $\pounds$ 6,371.90). The corresponding under-recovery for 2001 amounts to  $\pounds$ 8,409.54.

3.9 The Group noted that, in addition to the three States mentioned in paragraph 3.8 above, three other States, Indonesia, Morocco and the Russian Federation, which were assessed for the year 2001 by the SCRAG/1 Meeting, have not paid their SADIS cost shares for this year and consequently had the SADIS service withdrawn. The corresponding under-recovery for 2001 amounts to £33,975.81.

3.10 Having noted the information in Table 1 and paragraphs 3.6 to 3.9 above, the Group agreed that the net amount of the under-recovery of SADIS cost shares for the year 2001 amounts to £47,971, which is the difference between the actual costs for 2001 ( $\pounds$ 509,058) and the collections from States for 2001 as at 15 October 2002 ( $\pounds$ 461,087), and it formulated the following Conclusion:

Conclusion 3/2 -

A net under-recovery, amounting to £47,971 of the SADIS cost shares for the year 2001 will be taken into account in the calculation of the SADIS cost shares for the year 2003, in accordance with Article XI, paragraph 4 of the SADIS Agreement.

## AGENDA ITEM 4: REVIEW OF ESTIMATED SADIS COSTS AND COST SHARES FOR THE PERIOD 1 JANUARY TO 31 DECEMBER 2003

4.1 The Group reviewed the cost estimates provided by the United Kingdom for providing the SADIS services in the year 2003. These cost estimates are detailed in **Appendix F** and total £ 460,506. A summary of these costs is presented in **Table 2**. The Group agreed that a maximum amount of £40,000 be allocated to 2G trial in 2003. The Group also agreed that, in period of high inflation, it might be more appropriate to show the estimated costs inclusive of forecast inflation.

4.2 The Group considered the under-recovery in paragraph 3.10 above in the calculation of the amount to be assessed under the SADIS Agreement for 2003. The calculation of the amount to be assessed is presented in **Table 3**.

4.3 The Group determined the cost share for the period 1 January to 31 December 2003 to be borne by the States parties to the SADIS Agreement which are not exempted because they are on the list of the Least Developed Countries or because they denied their accession to the SADIS Agreement, on the basis of the number of available tonne-kilometres (ATKs) in scheduled services for 2001, in accordance with Article XI, paragraph 3 of the SADIS Agreement. The cost share in percentage terms and the share in £ sterling, including the share of under-recovery for 2001, to be borne by each State are shown in **Appendix G**.

4.4 The Group then agreed that the United Kingdom, would proceed to bill each of the States party to the SADIS Agreement for the share attributable to it as shown in **Appendix G**. Accordingly the Group formulated the following Conclusion:

Conclusion 3/3 -

The estimated cost shares for 2003 as shown in Appendix G for each State participating in the SCAR Arrangement are approved by the SCRAG/3 Meeting for collection by the United Kingdom.

4.5 Appendix H recapitulates the amounts due by the States participating in the SCAR arrangement as at 1 January 2003, subject for each State to adjustments to take into account the payments received after 15 October 2002.

# **Depreciated Assets**

4.6 The Group noted the information presented by the UK regarding the depreciated assets as at 31 December 2002 (see **Appendix C**).

#### Cost estimates for the years 2004 to 2006

4.7 The Group considered the estimates provided by the United Kingdom (see **Appendix F**) and summarised in **Table 4** of providing the SADIS services for the years 2004 to 2006 as well as the estimates for the United Kingdom administrative costs and the costs of ICAO support services. The Group noted that increased costs in the years 2004 to 2006 were due to the gateway function, of which the planned operational date is 1 September 2003.

# AGENDA ITEM 5: AMENDMENT TO ANNEX II, SADIS INVENTORY, TO THE AGREEMENT ON THE SHARING OF COSTS OF THE SATELLITE DISTRIBUTION SYSTEM RELATING TO AIR NAVIGATION

5.1 The Group reviewed the amendments to Annex II, SADIS Inventory, to the SADIS Agreement as proposed by the SADISOPSG Group and agreed upon by the United Kingdom as the SADIS provider State. These amendments were necessary to ensure that the Inventory would continue to meet the approved operational requirements and take account of the complementary second SADIS carrier.

5.2 The additions and deletions to the existing text of Annex II appear in outline and strikeout formats in **Appendix I**. As a result of its review, the group adopted the following Conclusion:

Conclusion 3/4 -

With the consent of the United Kingdom as the SADIS provider State, in accordance with Article XVII, paragraph 5, of the SADIS Agreement, Annex II, SADIS Inventory of the SADIS Agreement is amended as indicated in Appendix I.

# AGENDA ITEM 6: FUTURE WORK AND ARRANGEMENTS FOR THE SCRAG/4 MEETING

6.1 The Group agreed that its next meeting should normally be held in the ICAO Regional Office of Bangkok (Thailand) on 4 and 5 November 2003.

#### AGENDA ITEM 7: OTHER BUSINESS

7.1 The group agreed in principle that the actual costs of providing the SADIS services by the UK Met Office be audited on an annual basis by PKF, a substantial firm of auditors who routinely provide internal audit services to the Met Office, before being presented to the SCRAG. However, the implementation of this procedure is subject to approval of the costs involved and terms of reference of such audits by the SCRAG/4 meeting.

7.2 Two proposals which had been presented in flimsies by the United Kingdom at the opening of the SCRAG/3 Meeting, on the basis of the intention expressed by Astrium in September 2002 to withdraw from the services which they provided in support of the SADIS programme, were withdrawn by the United Kingdom without being discussed. The first proposal was to consider the benefits of the SADIS provider owning the intellectual property rights (IPR) associated with the SADIS service. The second proposal was to consider a maintenance facility of SADIS receiver equipment, with the costs shared between all SADIS users, in order to guarantee an agreed level of support from the receiver provider for an agreed cost. These two proposals were withdrawn by the United Kingdom as a result of a new communication received from Astrium during the Meeting on 5 November 2002. The SCRAG were informed that further discussions will be taking place with Astrium over the IPR and other issues and the SADISOPSG will be kept informed of any new developments in this respect.

7.3 The Group expressed its sincere appreciation to the UK Met Office for the excellent meeting arrangements and hospitality extended, as well as for the fine arrangements made for the visit to the SADIS provision locations.

# APPENDIX I AMENDMENT TO ANNEX II, SADIS INVENTORY, TO THE SADIS AGREEMENT

#### SADIS INVENTORY

The inventory items identified below cover the equipment and staffing required to provide, operate and maintain the SADIS. The inventory includes: hub infrastructure (including all additions following the completion of the hub enhancement project) and communications circuits, ISCS data back-up system, procured services, and staff. It should be noted that some equipment items are under lease and form part of a wider infrastructure. Costs of individual items cannot be separated from the required infrastructure that includes a significant part of the development of the software and technical configuration. The inventory is in accordance with the SADIS User Guide and as listed (in part) in the ICAO ESCRAG/7 Meeting Report.

# **1. EQUIPMENT**

#### A. Hub infrastructure and communications circuits

The hub infrastructure connection to the MET Office message switch (TROPICS) consists of a number of units developed in conjunction with Astrium and other suppliers. These are installed either at Bracknell or at the uplink site at Whitehills, Oxford. The components of the original inventory have changed as when the Two-Way enhancement project is was fully implemented. More specifically, the inventory of units or items includes those: It should be noted that the Met Office is in the process of upgrading its message switch which will be known as FROST.
