# **INTRODUCTION**

#### **Place and duration**

i.1 The Seventh Meeting of the SADIS Cost Recovery Administrative Group (SCRAG) was held in the Asia and Pacific (ASIA/PAC) ICAO Regional Office, Bangkok, on 1 and 2 November 2006.

## Attendance

i.2 The Meeting was attended by two of the five Members of the Group and two of the three Observers. The list of participants is in **Appendix A** and a list of working papers issued for the Meeting is in **Appendix B**.

#### **Officers and Secretariat**

i.3 Mr. L.J.N. Rolvink, from the Netherlands, was Chairman of the Meeting. Mr. C. Gauthier, Coordinator, Joint Financing, ICAO Headquarters, Montreal, acted as Secretary of the Meeting, assisted by Dr. Paul G. Hooper, Regional Officer, Air Transport and Mr. Dimitar H. Ivanov, Regional Officer, Aeronautical Meteorology.

# AGENDA ITEM 1: REVIEW OF SCRAG'S TERMS OF REFERENCE, COMPOSITION AND WORKING ARRANGEMENTS

1.1 The Group noted that the Parties to the SADIS Agreement from the European Region still represent in the aggregate more than 50% of the total assessments, which results in the nomination of two SCRAG members from this Region, in accordance with Article VII, paragraph 2 of the SADIS Agreement.

1.2 The Group noted its Terms of Reference assigned by Article VII of the SADIS Agreement, which reads:

"The SADIS Cost Allocation and Recovery (SCAR) arrangement shall be administered by a group, the *SADIS Cost Recovery Administrative Group* (SCRAG) which shall:

- a) assess the annual cost share attributable to each Party, including re-assessments arising from new Parties adhering to this Agreement; and
- b) audit the costs of the SADIS provision and any related financial activities, incurred by the provider State and subject to cost sharing."

1.3 The Group was informed that ICAO had received a formal notification of accession to the SADIS Agreement from 44 States, that 11 States had informed ICAO of their intention to accede to the SADIS Agreement but had not yet sent a formal notification of accession and that 38 other States receiving the SADIS service had not yet notified their intention to accede to the SADIS Agreement. It was also informed that from these last 38 States, 19 are Least Developed Countries (LDCs), which are exempted from payment of SADIS cost share.

## AGENDA ITEM 2: CONSIDERATION OF ISSUES RELEVANT TO THE SCRAG'S WORK ADDRESSED BY THE SADIS OPERATIONS GROUP (SADISOPSG)

2.1 The Group was informed of the main conclusions of the Eleventh Meeting of the SADIS Operations Group (SADISOPSG/11, Cairo, 23 to 25 May 2006) provided by the Chairman of SADISOPSG in the Executive Summary of Discussions of this meeting.

2.2 The Group noted the Statement of SADIS operational efficacy received from the Chairman of SADISOPSG relaying the advice from the Group at its Eleventh meeting (SADISOPSG/11, Cairo, 23 to 25 May 2006) to SCRAG that the operational efficacy of the SADIS had continued to be satisfactory meeting all operational requirements since the SADISOPSG/10 Meeting (Paris, 24 to 27 May 2005).

2.3 The Group noted Conclusion 11/6 of SADISOPSG/11 instructing the Chairman of SADISOPSG to forward to the Chairman of SCRAG an updated SADIS Inventory. This proposal is dealt with under Agenda Item 5 (see below paragraphs 5.1, 5.2 and **Appendix I**).

2.4 The Group also noted Conclusion 11/21 of SADISOPSG/11 regarding the implementation of back-up service to the SADIS broadcast and that the SADIS provider State be invited to present an estimate of the costs involved for approval at the SCRAG/7 Meeting. Consequently, a working paper (WP/14) was prepared by the SADIS provider State to be discussed under Agenda Item 4 (see below paragraph 4.2).

# AGENDA ITEM 3: REVIEW OF ACTUAL SADIS COSTS AND COST SHARES FOR THE PERIOD 1 JANUARY TO 31 DECEMBER 2005

## **Review of the 2005 Actual SADIS Costs**

3.1 The Group reviewed the actual costs of providing the SADIS services in the year 2005. These actual costs are presented in **Appendix E** and total £548 497. A summary of these costs is presented in **Table 1**.

#### **Review of the 2005 Actual SADIS Cost Shares**

3.2 The Group noted that one State, Mongolia, which was assessed for the year 2005 by the SCRAG/5 Meeting, did not have an operational equipment in 2005. Consequently, its share of the actual costs for 2005 is nil.

3.3 The Group noted that one State, Indonesia, which was assessed for the year 2005 by the SCRAG/5 Meeting, has had the SADIS service withdrawn on 6 August 2002. Consequently, its share of the actual costs for 2005 is nil.

3.4 The Group determined the actual cost shares for the period 1 January to 31 December 2005 to be borne by the States party to the SADIS Agreement which are not exempted because they are on the list of the Least Developed Countries or because they denied their accession to the SADIS Agreement, on the basis of the number of available tonne-kilometres (ATKs) in scheduled services for 2005, in accordance with Article XI, paragraph 3 of the SADIS Agreement. The cost share in percentage terms and the share in £ sterling to be borne by each State participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement are shown in **Appendix E**. Accordingly the Group formulated the following Conclusion:

Conclusion 7/1 -

The actual cost shares for 2005 as shown in Appendix E to the SCRAG/7 Report for the States participating in the SCAR Arrangement are approved by the SCRAG/7 Meeting, in view of the adjustments to be made by the United Kingdom in its billing of these States.

3.5 The Group received information from the observer from the United Kingdom on the status of payment of the cost shares of 2005 as at 13 October 2006. It noted that a total amount of £469 245 was collected and a total amount of credit balance of £12 910 was applied against the assessments for 2005 (see **Appendix G – Table 1**), both amounts representing 92.8% of the original assessments for 2005 as approved by the SCRAG/5 Meeting.

3.6 The Group noted that despite several reminders, there are still a few States that have not yet paid their assessment for the year 2005. The Group agreed that service to these States be terminated and reinstated only after full payment is received.

3.7 Having noted the information in Table 1 and paragraphs 3.2 to 3.6 above, the Group agreed that the net amount of the under-recovery of SADIS cost shares for the year 2005 amounts to £51 336 as shown in **Table 2**. This under-recovery is the difference between the actual costs for 2005 (£548 497), to which the over-recovery for 2003 is subtracted (£5 801) in order to obtain the amount subject to collection for 2005, and the collections from States for 2005 (£469 245 as shown in **Appendix G - Table 1**) plus the collections from States for years prior to 2005 after 31 December 2005 (£22 115 as shown in **Appendix G - Table 2**), and it formulated the following Conclusion:

Conclusion 7/2 -

A net under-recovery, amounting to £51 336 of the SADIS cost shares for the year 2005 will be taken into account in the calculation of the SADIS cost shares for the year 2007, in accordance with Article XI, paragraph 4 of the SADIS Agreement.

3.8 The Group noted the information presented by the United Kingdom regarding the depreciated assets as at 31 December 2006 (see **Appendix C**).

# AGENDA ITEM 4: REVIEW OF ESTIMATED SADIS COSTS AND COST SHARES FOR THE PERIOD 1 JANUARY TO 31 DECEMBER 2007

## **Review of the 2007 Estimated SADIS Costs**

4.1 The Group reviewed the cost estimates for providing the SADIS services in the year 2007. These cost estimates are detailed in **Appendix F** and total  $\pounds$ 701 334. A summary of these costs is presented in **Table 3**.

4.2 The Group considered a proposal by the provider State for SADIS backup enhancement and the corresponding budget estimates. The Group noted that the estimated costs of £29 141 in 2007 represent the cost of implementing a SADIS back-up of WAFC services as discussed at SADISOPSG/11. As a result of its deliberations, the Group adopted the following Conclusion:

Conclusion 7/3 -

The SCRAG approves the budgetary costs presented by the SADIS provider State for SADIS backup enhancement as discussed at SADISOPSG/11.

#### **Review of the 2007 Estimated SADIS Cost Shares**

4.4 The Group determined the cost shares for the period 1 January to 31 December 2007 to be borne by the States party to the SADIS Agreement which are not exempted because they are on the list of the Least Developed Countries, on the basis of the number of available tonne-kilometres (ATKs) in scheduled services for 2005, in accordance with Article XI, paragraph 3 of the SADIS Agreement. The Group noted that two new receiver States, Mongolia and the Syrian Arab Republic, are included in the calculation of the assessment of cost shares for 2007. The cost share in percentage terms and the share in £ sterling, including the share of under-recovery for 2005, to be borne by each State are shown in

## Appendix H.

4.5 The Group asked that the Secretariat and the provider State ensure that the administrative functions be carried out as cost-effectively as possible.

4.6 The Group agreed that the figures in Conclusion 7/2, tables 2 and 4 above and in Appendix H will be updated before the United Kingdom proceed to bill each of the States party to the SADIS Agreement for the share attributable to it in 2007, to take into account any payment received between 13 October and 31 December 2006. Accordingly, the Group formulated the following Conclusion:

Conclusion 7/4 -

Subject to updating by the Secretariat to take into account any payment of arrears received between 13 October and 31 December 2006, the estimated cost shares for 2007 as shown in Appendix H to the SCRAG/7 Report for each State participating in the SCAR Arrangement are approved by the SCRAG/7 Meeting for collection by the United Kingdom.

#### Cost estimates for the years 2008 to 2010

4.7 The Group considered the estimates provided by the United Kingdom (see **Appendix F**) and summarised in **Table 5** of providing the SADIS services for the years 2008 to 2010 as well as the estimates for the United Kingdom administrative costs and the costs of ICAO support services.

## AGENDA ITEM 5: AMENDMENTS TO ANNEXES TO THE AGREEMENT ON THE SHARING OF COSTS OF THE SATELLITE DISTRIBUTION SYSTEM RELATING TO AIR NAVIGATION

5.1 The Group reviewed the amendments to Annex II, SADIS Inventory, to the SADIS Agreement as proposed by the SADISOPSG and agreed upon by the United Kingdom as the SADIS provider State. These amendments were necessary to ensure that the inventory would continue to meet the approved operational requirements, to take account of minor changes in the proportions of resource usage and to improve failover between contingent links and the operator visibility of network performance. The additions and deletions to the existing text of Annex II appear in outline and strikeout formats in **Appendix I**.

5.2 The Group asked that the SADISOPSG be informed that at its next meeting it should propose an amendment to Annex II, SADIS Inventory, to the SADIS Agreement, in order to remove the reference to "management and invoicing" in section 3, sub-section A, paragraph ii), item 5 which reads under "Additional support": "Contract procurement, management and invoicing".

5.3 The Group also reviewed an amendment to Annex III, Financial Issues, to the SADIS Agreement as proposed by the United Kingdom as the SADIS provider State. This amendment, in paragraph 1 e) of the section on chargeable costs, consists of replacing in the last sentence the reference to UK-CAA by United Kingdom since as of 1 January 2007 the UK Met Office will take over the administrative functions from the UK-CAA. The transfer of these functions is not expected to lead to a significant change in the administration costs of SADIS. The Group asked that when sending the next bill to each of the States party to the SADIS Agreement, that the UK Met Office include a letter explaining the administrative change.

5.4 As a result of its review, the Group adopted the following Conclusion:

Conclusion 7/5 -

With the consent of the United Kingdom as the SADIS provider State, in accordance with Article XVII, paragraph 5, of the SADIS Agreement, Annex II, SADIS Inventory, of the SADIS Agreement is amended as indicated in Appendix I to the SCRAG/7 Report and Annex III, Financial Issues, of the SADIS Agreement is amended as indicated in paragraph 5.3 of the SCRAG/7 Report.

## AGENDA ITEM 6: FUTURE WORK AND ARRANGEMENTS FOR THE SCRAG/8 MEETING

6.1 The Group agreed that, subject to confirmation, its Eight Meeting should be held in the ICAO European and North Atlantic Region Office (Paris) during the first week of November 2007.

## AGENDA ITEM 7: OTHER BUSINESS

7.1 The Group expressed its appreciation and thanks to the staff of the Asia and Pacific (ASIA/PAC) ICAO Regional Office for their hospitality and excellent support received during the meeting.

#### SADIS INVENTORY

The inventory items identified below cover the equipment and staffing required to provide, operate and maintain the SADIS. The inventory includes: hub infrastructure (including all additions following the completion of the hub enhancement project) and communications circuits, ISCS data back up system, procured services, and staff. It should be noted that some equipment items are under lease and form part of a wider infrastructure. Costs of individual items cannot be separated from the required infrastructure that includes a significant part of the development of the software and technical configuration. The inventory is in accordance with the SADIS User Guide.

#### 1. EQUIPMENT

## A. Key components of Hub infrastructure and communications circuits

The SADIS 1G hub infrastructure connection to the Met Office message switch (FROST) consists of a number of units developed in conjunction with EADS Astrium and other suppliers. These are installed either at Exeter or at the uplink site at Whitehill, Oxfordshire, UK.

Additional hub infrastructure has been installed at Exeter and Whitehill to provide resilient SADIS 2G service. This hardware is physically separate from the SADIS 1G infrastructure.

#### i) Solely procured for SADIS (major components)

SADIS gateway function software (developed specifically for the gateway as part of the NATS CoreMet system; see items under "Not procured principally for SADIS").

Hewlett Packard L-class servers to provide SADIS FTP service (see Section 1 C).

#### ii) **Principally procured for SADIS**

a) At the Met Office;

See Section 1 C for itemized components.

- b) Communications between Whitehill and Met Office;
  - 1) 2 Fibre Optic 64 Kbps circuits in support of SADIS 1G service; and
  - 2) 2 Fibre Optic 64 Kbps circuits in support of SADIS 2G service
- c) At the uplink site (Whitehill);
  - 1) Units forming part of a totally integrated rack structure to provide SADIS 1G service, with back-up, referred to as Chain A and Chain B (see the list under Section 1 C);

- 2) Units and services leased from Cable and Wireless Communications Ltd. to support SADIS 1G and 2G services:
  - i) 1 (70 to 140 MHz) convertor;
  - ii) Use of 1 (140 to C band) convertor;

iii) Use of satellite hub C (Lease represents only a very small part of this large aperture) for SADIS 1G and 2G services; and

- 3) Units forming part of a totally integrated rack structure to provide SADIS 2G service, with back-up (see the list under Section 1 C).
- d) Communication link (SVC) between SADIS Gateway and Met Office in support of SADIS 1G service; and
- e) Communication link utilising WMO TCP/IP sockets protocol) between SADIS Gateway and Met Office in support of SADIS 2G service. (*Note.— It is expected that this single link will be upgraded to dual contingent links within the next 12 months.*)

#### iii) Not procured principally for SADIS
