1. INTRODUCTION

- 1.1 The Fifth Meeting of the AFI Planning and Implementation Regional Group (APIRG) Infrastructure and Information Management Sub-group (IIM/SG5) was held virtually from 26 to 29 July 2022. The Report of the meeting is available on the ICAO WACAF website.
- 1.2 The outcomes of the meeting were recorded in the form of Conclusions and Decisions that are defined as follows:
 - a) Conclusions deal with matters which, in accordance with the Groups' terms of reference, merit directly the attention of States, or on which further action is required to be initiated by the Secretary in accordance with established procedures.
 - b) Decisions relate to the internal working arrangements of the Groups and their subsidiary bodies.
- 1.3 The IIM/SG5 meeting adopted six (6) Conclusions and twelve (12) Decisions. Two (2) Conclusions were not submitted to APIRG/25 meeting. This Paper provides the status of the implementation of these two Conclusions and one Decision. Working Paper 2.2. provides the status of the implementation of the IIM/SG5 related Conclusions and Decisions approved by APIRG/25.

2. DISCUSSION

- 2.1 The IIM/SG5 meeting discussed ten (10) Agenda Items and urged States/Organizations to embark on the effective implementation of outstanding Conclusions and Decisions of the IIM/SG5 and other previous IIM/SG meetings. The status of implementation of the Conclusions and Decisions in the MET, CNS and AIM areas is as attached in **Appendix A**
- 2.2 In addition, the IIM/SG5 meeting was informed that the Sub-Group's Projects are not operating at the same pace and many of them are not meeting the objectives of their Projects. The meeting urged the Secretariat to convene a specific meeting of the IIM Projects' PTCs to discuss the challenges faced by the Project Teams.
