1. INTRODUCTION

1.1 The fourth meeting of the APIRG Infrastructure and Information Management Sub-Group (IIM/SG4) was held virtually from 10 to 13 August 2021, with the main objectives to:

- a) Review the Conclusions/Decisions of the Third meeting of the APIRG Infrastructure and Information Management Sub-Group (**IIM/SG3**) held Virtual Meeting, 12 to 14 October 2020;
- b) Review the outcome of the APIRG/23 meeting (virtual, 23 November - 2 December 2020) pertaining to the areas of Aeronautical Information Management (**AIM**), Aeronautical Communication Navigation Surveillance and Spectrum (**CNS**), Aeronautical Meteorology (**MET**);
- c) Review the status of implementation of APIRG adopted regional projects in the areas of **AIM**, **CNS** and **MET** for the implementation of the selected ASBU module elements for the AFI region; and;
- d) Review the Terms of Reference (ToRs) and work Programme of the Subgroup.

1.2 The meeting adopted and discussed eight (08) agenda items.

2. DISCUSSIONS

- 2.1 The IIM/SG4 meeting deliberated on 22 draft Conclusions and Decisions comprising 15 draft Decisions and 7 draft Conclusions.
- 2.2 Fifteen (15) out of the 22 Conclusions and Decisions were endorsed by the Sixth meeting of the APIRG APCC and submitted to APIRG/24 meeting and are presented in the WP2.2.
- 2.3 The status of the remaining 7 Conclusions and Decisions that were approved by the IIM/SG4 meeting are as presented in Appendix 1 to this Working Paper.
- 2.4 Four (4) out of the 7 Conclusions and Decisions are completed, two (2) are in progress and one (1) is not implemented
