Subject: FPP Flight Validation for Pilot Course (No. 2), Colombo, 17 November-5 December 2014

Action Required: Respond by 31 October 2014

Sir/Madam,

I have the honor to inform you that the ICAO Asia-Pacific Flight Procedure Programme (FPP) will conduct a Flight Validation for Pilots Course on 17 November to 5 December 2014 hosted by Civil Aviation Authority of Sri Lanka, which is located at No. 04, Hunupitiya Road, Colombo, Sri Lanka. This course, its instructional material and training simulators are made possible by the kind contributions from Sri Lankan Airlines, Jetstar Australia, AirServices Australia, CAA Pakistan, AEROTHAI, and Boeing/Jeppesen.

Upon completion of this course, successful candidates will be able to conduct flight validation for all types of instrument flight procedures in accordance with ICAO Doc 9906 Volume V. To provide the best training environment, the enrolment for this course will be limited to 16 qualified candidates.

Training candidates should be pilots employed by a regulatory authority, or an authorised service provider who are qualified and experienced in RNP APCH and/or RNP AR operations. Experience in FMS equipped aircraft is desirable but not essential. They should have adequate communication skill in English and are expected to be senior experienced pilots. Suitable candidates include current or former flight operation inspectors or flight inspection pilots. It is also recommended that candidates have a sound knowledge of Performance Based Navigation (PBN) operations, and particularly PBN approach operations.

You are cordially invited to nominate a maximum of two qualified participants for attendance at the Flight Validation for Pilots Course. For more than one candidate per State will be offered only if spare places available. Available slots in this course will be provided to the States that are participating in the APAC FPP, as either an Active Participating State or User State. Since the APAC FPP Office expects that there will be considerable demand for this course, priority should be indicated if more than one person is nominated. Relevant resume' of each candidate including a statement of qualifications and flight experience should be submitted as part of the registration to assist candidate selection process. There will be no charge for the training course for APAC FPP the member states; however, your administration is expected to fund the travel, accommodation and living expenses for your nominees.

Attached are the detailed course information, registration form and list of hotels. Transportation between the hotel listed and the training venue could be arranged. I would kindly request that States should nominate participant(s) by registering for the course no later than 31 October 2014. Following the acceptance
