#### CHANGES TO AUSTRALIAN ENTRIES IN OPMET ICD HANDBOOK

#### **SUMMARY**

This paper requests a minor update to OPMET ICD Handbook to reflect current operations. Action by the MET/IE-WG is in paragraph 3.

#### 1. INTRODUCTION

- 1.1 The Asia/Pacific OPMET Data Banks Interface Control Document (OPMET ICD) describes the standard interrogation procedures for accessing the designated Regional OPMET Databanks (RODB) in the ASIA/PAC Region and meteorological contents of bulletins held by the RODBs.
- 1.2 Australia has previously requested updates to the OPMET ICD Handbook and it has been discovered that these changes were only partly completed and two old entries Australia bulletin entries (SAAU32 and SAAU31) remain within Appendix E.

### 2. DISCUSSION

### **OPMET ICD Changes**

2.1 Appendix E of the OPMET ICD lists details of RODB Tokyo. Currently there are two entries for both SAAU31 and SAAU32, these being from source centre (CCCC) of AMMC and YBBN. The AMMC is an old entry and should be deleted.
