1 INTRODUCTION

1.1. The APIRG/26 and RASG-AFI/9 Joint Session agreed to merge the two existing groups in a single structure made up of the Programme Review and Coordination Committee (PRCC), the two current APIRG sub-groups (Infrastructure and Information Management Sub-Group (IIM/SG) and Airspace and Aerodrome Operations Sub-Group (AAO/SG)), and a third sub-group called the Safety Oversight and Management Sub-Group (SOM/SG). The Joint session, through its APIRG/26 & RASG-AFI/9 Decision 5/05, tasked the Secretariat to:

- expedite the finalization of the study based on stakeholders' comments, including the development of the Procedural Handbook as well as the schedule of the transition period and other related arrangements by June 2024; and
- coordinate with APIRG and RASG-AFI Chairpersons, for an extraordinary APIRG and RASG-AFI joint meeting to review and approve the proposals.

- 1.2. The Extraordinary Meeting of APIRG and RASG-AFI held on 19 July 2024 in Libreville, Gabon, reviewed the results presented by the Secretariat and endorsed the name of the merged Entity known as the “Africa – Indian Ocean Aviation System Planning and Implementation Group (AASPG)” as well as the new structure of the AASPG.
- 1.3. The meeting agreed to deliberate on the transitional arrangements presented by the Secretariat during the upcoming APIRG and RASG-AFI Meeting to be held in November 2024 in South Africa.
- 1.4. The working paper is presenting for review the transitional arrangements from the current APIRG and RASG-AFI groups to the new AASPG.

2 DISCUSSIONS

Approval of the AASPG by the ICAO Council

- 2.1. Both APIRG and RASG-AFI are regional Groups established by the ICAO Council. The APIRG was set up by the Council of ICAO, in 1980, as recommended by the Sixth AFI Regional Air Navigation Meeting (AFI/6) held in 1979. The ICAO Council at the fourth meeting of its 190th Session held on 25 May 2010, through the Decision C-DEC 190/4, approved the establishment of RASGs including the RASG-AFI for the Africa-Indian Ocean Region, with the aim of supporting a regional performance framework for the management of safety.
- 2.2. The new group AASPG replacing APIRG and RASG-AFI will be submitted to the ICAO Council for endorsement.

Transitional arrangements

- 2.3. The following principles are proposed for consideration by the APIRG/27&RASG-AFI/10 meeting as transitional arrangements between the two groups and the new AASPG:
 - a) The APIRG and RASG-AFI, and their contributory bodies, to continue their activities until the operationalization of the AASPG.
 - b) Activities will be carried out for this purpose as follows:
 - i. The IIM and AAO sub-groups under the APIRG framework to continue their activities under the AASPG in normal course, for reporting to the AASPG through the PRCC; and the new SMO sub-group to start its activities with a first meeting that should report to the first ordinary meeting of the AASPG through the PRCC;
 - ii. A first meeting of the AASPG to be convened by the current secretary of APIRG who should ensure its secretariat; The said meeting should ensure continuity of business from APIRG and RASG-AFI to the new Group; It would be chaired by the Chairperson of APIRG assisted by the Chairperson of RASG-AFI;
 - iii. The first meeting of the AASPG should elect its Chair and Vice-chairs who would take over business of the Group at the closure of the meeting. The current RASG-AFI Secretary will ensure the Secretariat of the new group after this first meeting;

- iv. The APIRG and RASG-AFI should cease existence after the first meeting of the AASPG to be held in 2025 and the relevant outstanding matters of the so terminated Groups should be taken over by the AASPG.
