E) E) IN ACCORDANCE WITH THE DIRECTIVE ISSUED BY THE GOVERNMENT OF KENYA AIMING AT PREVENTING THE SPREAD OF CORONAVIRUS (COVID-19), THE FLW PROCEDURES WILL APPLY:  
1) FOREIGN AIRLINES WILL BE ALLOWED TO FLY IN KENYANS AND FOREIGNERS WITH VALID RESIDENCE PERMITS INTO THE COUNTRY AND FLY OUT FOREIGNERS WHO ARE IN THE COUNTRY AS TOURISTS OR ON BUSINESS TRIPS TO THEIR COUNTRIES OF ORIGIN.  
2) INCOMING PAX WILL BE MEDICALLY CLEARED AT THE ENTRY POINTS BY PORT HEALTH AND TO SELF QUARANTINE OR TO A GOVERNMENT DESIGNATED QUARANTINE FACILITY FOR 14 DAYS.  
3) TRANSIT PAX WILL BE CHECKED BY PORT HEALTH;  
4) AIRLINE CREW TO BE ACCOMMODATED AT DESIGNATED HOTEL WITHIN THE AIRPORT AND THEIR MOVEMENTS RESTRICTED.  
5) CARGO FLTS ARE EXEMPTED FROM ABOVE RESTRICTIONS;  
6) CARGO FLTS CREW WILL BE HANDLED AS PER PASSENGER AIRLINES CREW.  
7) ACCREDITED DIPLOMATS AND MEMBERS OF INTERNATIONAL NON-GOVERNMENTAL ORGANIZATIONS ON MEDICAL EMERGENCY/EVACUATION ARE ALLOWED TO FLY INTO KENYA AFTER APPROVAL  
BY MINISTRY OF FOREIGN AFFAIRS AND IN CONSULTATION WITH THE MINISTRY OF HEALTH AND MINISTRY OF TRANSPORT ;  
8) GOVERNMENT WILL NOT AUTHORIZE DEPORTATION FROM ANY COUNTRY OF MORE THAN 5 PERSONS THRU JKIA  
9)ALL INCOMING PAX MUST FILL IN A FORM ISSUED BY PORT HEALTH ON ARRIVAL BEFORE IMMIGRATION THAT THEY COMMIT TO UNDERGO MANDATORY SELF QUARANTINE FOR 14 DAYS. FAILURE TO COMPLY WILL CONSTITUTE AN OFFENSE UNDER THE PUBLIC HEALTH ACT AND WILL BE SUBJECT TO FINE AND/OR IMPRISONMENT  
10) IF SUSPECTED CASES OF THE VIRUS ARE IDENTIFIED, INFORM PORT HEALTH THROUGH ATC THE FLW INFO.
