Sir/Madam,

I have the honour to invite your Administration to nominate participants for a workshop on Airport and Air Navigation Service Economics to be held from 23 to 25 March 2010 on the premises of the ICAO Regional Office for the Eastern and Southern Africa in Nairobi, Kenya. The workshop is a follow-up event to the Conference on the Economics of Airports and Air Navigation Services (CEANS) held in Montreal in September 2008 and the outcome of the conclusions of the Joint ICAO/AFCAC Regional Symposium held on the same subject from 17 to 19 August 2009 in Kampala, Uganda, particularly in accordance with *Point 5 of the Conclusions "Requesting ICAO and AFCAC to assist African States, through workshops, seminars and other appropriate means, in raising the awareness of the States of these ICAO policies, in order to promote their implementation"*.

Workshop discussions will mainly be around ICAO's *Policies on Charges for Airports and Air Navigation Services (Doc 9082 – Eighth Edition)*, CEANS Recommendations and the conclusions of the Kampala Symposium, with emphasis on the Follow up Actions agreed by the Symposium. The workshop will also have to define the best ways and means to collect financial data for the management of airports and air navigation services in Africa. It will also provide an opportunity to elaborate the provisional agenda of the next **Joint ICAO/AFCAC Regional Symposium on Aeronautical Infrastructure Financing in Africa** to be held in Maputo, Mozambique in July 2010. The workshop agenda is attached to this letter; further organizational details will be provided later.
