You are kindly reminded that, in accordance with the current NAFISAT Memorandum of Understanding (MoU), signed in 2015 in Sharm El Sheikh, Egypt, the NAFISAT network will pay for "two (2) representatives (one technical and one financial) from each participating Member State" and the cost of other representatives will be borne by the State or the respective network service provider. (MOU - Para 2.1 and 2.2 of Annex B of the Terms of Reference of the NAFISAT Supervisory Board refers).

Your Administration/Organization is also requested to indicate your intention to present a working paper for coordination with the ICAO Secretariat not later than **11 August 2017**.
