OBLIGATIONS OF ICAO MEMBER STATES IN SAR

2.1.1

Contracting States shall, individually or in cooperation with other States, arrange for establishment and prompt provision of search and rescue services within their territories to ensure that assistance is rendered to persons in distress. Such service shall be provided on 24-hours basis.

3.1 Cooperation between States

3.1.1

Contracting States shall coordinate their SAR organization with those of neighbouring States.

3.1.2

Contracting States should, whenever necessary, coordinate their search and rescue operations with those of neighbouring States especially when these operations are proximate to adjacent search and rescue regions.

3.1.2.1

Contracting States should, in so far as practicable, develop common search and rescue plans and procedures to facilitate coordination of search and rescue operations with those of neighbouring States.

Facilitation of search, rescue, accident investigation and salvage


8.3 Contracting States shall make arrangements to ensure entry without delay into their territories on a temporary basis of qualified personnel required for search, rescue, accident investigation, repair or salvage in connection with a lost or damaged aircraft.

8.3.1 In arranging for the entry without delay of the personnel, States shall not require any other travel document than a passport.

High-level regional SAR conferences held in Serbia in 2015 and 2016

Main conclusions:

Recognized the need for regional cross-border cooperation for the efficient conduct of aeronautical SAR operations

Invited the Serbian CAD (Civil Aviation Directorate of the Republic of Serbia) to formalize regional cross-border cooperation by the end of 2016

Invited EUROCONTROL, ICAO and States to assess the need and, in case of missing agreements, to conclude as soon as possible SAR cross-border bilateral agreements in accordance with Annex 12

Invited EUROCONTROL and States involved in the regional cross-border cooperation to support implementation of the ICAO Global Aeronautical Distress and Safety System (GADSS)

Recognising the **need for harmonizing and strengthening** international cooperation and especially **regional cooperation** for the efficient conduct of **aeronautical SAR** operations

Recognising the efforts by the ICAO EUR/NAT European SAR Task Force to promote the enhancement and improvement of SAR facilities and services within the EUR Region and adjacent regions

Respecting the equity and voluntary membership in regional cooperation

Bearing in mind the **conclusions** of the Regional Civil Aviation Authorities meeting, held in Belgrade on 22 January 2015 and the **Regional Search and Rescue Conference**, held in Belgrade on 9 and 10 February 2016



Establishment of RASARAC

Memorandum of Understanding on the establishment of the <u>Regional</u> **Aeronautical Search** and Rescue Advisory Committee (RASARAC) has been signed by the 8 States from Central and Southeast Europe on 03 Nov 2016





Provide an overview of the initiatives underway in the Central and Southeast European region for significant and sustainable improvement in the provision of Search & Rescue (SAR) services

Show that the most efficient way to meet the community's expectations of SAR services is achieved through cooperation among the region's States as well as inter-regional collaboration

Focus on the institutional and operational aspects of cross-border cooperation in SAR, and the identification of modalities for efficient collaboration to enhance the regional SAR system, including bespoke SAR training

Recommend the rationalisation of resources through regional cooperation and coordination in accordance with the technical and operational capacity of each State

Outline the improvements needed in the area of SAR and the impact of the Global Aeronautical Distress & Safety System (GADSS)



To analyse, and report on SAR regional training needs and potential solutions (*if existing*) with a focus on initial and specialist SAR operational, inspector and management tasks, plus theoretical, on-the-job and continuation training requirements

To verify and use, as appropriate, the relevant ICAO USOAP audit PQs in preparation of the aforementioned task

Deliverables

Reports, documents

Identified SAR training needs / priorities:

- 1. A course which provides SAR Coordinators / SAR Managers theoretical and practical knowledge on the planning and management of SAR organisations
- 2. A course which provides SAR Mission Coordinators theoretical and practical knowledge on aeronautical SAR operations and prepares them to conduct SAR operations in respective Rescue Coordination Centres

SAR Training Course for SAR Administrators and SAR Mission Coordinators was organised by Serbia with the Cyprus Joint Rescue Coordination Centre – JRCC Larnaca, in accordance with the recommendations and cooperation of ICAO EUR/NAT and EUROCONTROL

Two initial SAR training sessions have been organized by JRCC Larnaca for RASARAC States:

September 2019

1. Initial SMC training

November 2019

2. Initial SAR Manager training

To analyse, and report on SAR oversight issues and potential regional solutions (*if existing*) with a focus on systemic deficiencies, *c.q.* deficiencies that have a system-wide impact, identified in ICAO USOAP audits

To connect, as suitable, the above analysis to the conclusions and recommendations of WG 1, WG 2 and WG 3

To start developing standard SAR Compliance Checklists for use at regional level

To verify and use, as appropriate, the ICAO USOAP SAAQ as well as the USOAP audit PQs in preparation of the above said task

Deliverables

Reports, documents





Next steps:

Study, and aim for solutions regarding the regional development, *c.q.* improvement of SAR oversight activities, including through mechanisms such as peer reviews, in the context of furthering the development of regional cooperation in aeronautical SAR operations and promoting compliance with the SARPs.

WG will assist, amongst others, the proper interaction between the GADSS and SAR, and regional implementation of the GADSS; the effective implementation of a State Safety Programme (SSP); future certification processes for SAR; focused SAR training, etc.

WG 4 will refer to the IE-REST tasks on the challenges faced and best practices applied to overcome those challenges in the area of SAR safety oversight

2. International cooperation

Enhanced cooperation with international organizations: ICAO and EUROCONTROL

Enhance cooperation with training organizations like JRCC LCA and ECTL IANS

Enhance cooperation with the Eurpean Commission (DG GROW etc.)

Establish closer cooperation with international organizations: COSPAS-SARSAT, Singapore SAA, etc.
