RUNWAY SAFETY GO-TEAM VISIT TO KHARTOUM

(Presented by Secretariat)

SUMMARY

The First MID Runway Safety Go-Team Visit was conducted to Khartoum, Sudan from 30 November to 4 December 2014. The Go-Team was led by the ICAO MID Regional Office and supported by UAE, Egypt, IATA and ACI.

Action by the meeting is at paragraph 3.

1. Introduction

- 1.1 The third meeting of the Middle East Regional Aviation Safety Group (RASG-MID/3, Kuwait, 27-29 January 2014) endorsed through Conclusion 3/2 the Mechanism of Runway Safety (RS) Go-Team to expedite the establishment of RSTs and improve Runway Safety in the MID Region.
- 1.2 The MID RS Go-Team was officially launched during the Second Middle East Runway Safety Seminar (MID-RRSS/2, Dubai, UAE, 2-4 June 2014). The ICAO MID Regional Office was mandated to lead the RS Go-Team visits with support from UAE, Egypt, ACI, FAA, and IATA.

2. DISCUSSION

- 2.1 The first Middle East RS Go-Team visit was successfully conducted to Khartoum, Sudan from 30 November to 4 December 2014. The mission was led by ICAO MID Regional Office and supported by UAE, Egypt, IATA (with an observer from Qatar Airways) and ACI.
- 2.2 The RS Go-Team visit was based on the "Guidance for the Conduct of MID Runway Safety Go-Team Visits" that was developed by the MID-RRSS/2. The Runway Safety Go-Team Methodology developed within the framework of the ICAO Runway Safety Programme has also been taken into consideration.
- 2.3 The Go-Team visit was well appreciated by the Sudanese Civil Aviation Authority (SCAA) and the Khartoum International Airport (KIA) management. In parallel with the RS Go-Team, the Airport Council International conducted a Safety Review to KIA under the ACI APEX programme.

- 2.4 The RS Go-Team visit has included briefing on the ICAO Runway Safety Programme, the RASG-MID activities and the RST Handbook. It also included Workshops on RST establishment, Aerodrome Certification and Aerodrome Safeguarding as well as a presentation on IATA Global Aviation Data Management (GADM) related to KIA. The Go-Team Agenda is attached at **Appendix A**.
- 2.5 More than fifty (50) participants from the SCAA, KIA and other stakeholders have attended and interacted with the visit programme. As part of the Go-Team programme, a visit was conducted to the KIA. This provided a good opportunity to share experiences and lessons learned with the KIA team.
- 2.6 One of the major outcomes of the RS Go-Team was the official launch of the RST in KIA.
