# 1. INTRODUCTION

1.1 The Provisional Agenda for the Fourth meeting of the Runway and Ground Safety Working Group (RGS WG/4) has been prepared by the Secretariat in accordance with its TOR and the RASG-MID Work Programme.

2.2 The meeting may wish to note that Mr. Mohammad Faisal Al Dossari, Director Air Navigation & Aerodromes Department, General Civil Aviation Authority (GCAA), UAE has been acting as the RGS Chairperson and Coordinator with the MID Regional Aviation Safety Team (MID-RAST) under the RASG-MID framework since April 2014. Mr. Al Dossari has been playing a major role in the development of the RGS Safety Enhancement Initiatives (SEIs) and Detailed Implementation Plans (DIPs).

2.3 In accordance with the established procedures, the Chairperson of the Working Group should be elected each three years.

2.4 There is a need to re-elect a Chairperson to, inter-alia; chair the RGS WG meetings; keep focus on high priority Aerodrome Operations safety issues; assure timely implementation of the RGS DIPs; and coordinate the RGS activities closely with the Secretariat in order to meet the Terms of Reference, the RGS WG.
