1. INTRODUCTION

1.1 The meeting may wish to recall that the MIDANPIRG/16 meeting, through Conclusion 16/11, urged States to implement a system for AIRAC adherence monitoring; and report on annual basis (by 31 March) to the ICAO MID Office the case(s) of late publication of aeronautical information of operational significance and non-adherence to the AIRAC provisions, using the AIRAC Adherence Monitoring Questionnaire.

2. DISCUSSION

2.1 As a follow-up action to MIDANPIRG Conclusion 16/11, the ICAO MID Office issued State Letter Ref.: AN 8/4 - 18/020 dated 21 January 2018 urging States to report the status of their AIRAC adherence in 2017, using the "AIRAC adherence monitoring questionnaire" at **Appendix A**. Nine (9) States replied to the State Letter. The results of the analysis of AIRAC adherence in 2017 is provided in the following table:
