#### **1. INTRODUCTION**

1.1 The meeting may wish to recall that the MIDAD TF/4 meeting agreed that an EAD-MIDAD Workshop be conducted in EUROCONTROL Headquarters, Brussels, Belgium in order to discuss all the details related to the implementation of an EAD-based MIDAD project, and agree on a MIDAD implementation plan.

#### 2. DISCUSSION

2.1 The EAD-MIDAD Workshop was hosted by EUROCONTROL in Brussels, Belgium from 5 to 6 October 2017. The Workshop was attended by twenty one (21) participants, from six (6) States (Egypt, Iran, Iraq, Lebanon, Saudi Arabia and UAE) and three (3) International Organizations (CANSO, EUROCONTROL and ICAO).

2.2 The EAD-MIDAD Workshop provided an opportunity to address all the questions/concerns related to MIDAD Project based on the inputs received mainly from Iraq, Saudi Arabia, UAE and the ICAO MID Office.

2.3 The Workshop was presented with an update on the MIDAD Project. The Workshop was also apprised of the EAD experience and the EUROCONTROL proposal for the implementation of MIDAD.

2.4 The Workshop discussed the proposal and agreed on the following way forward:

Implementation phases	Phase Description	Responsible
Phase A	Individual migration of MID States to EAD	MID States
Phase B	Set-up of MIDAD Manager	MIDAD States, ICAO MID, EUROCONTROL (as advisor)
Phase C	Implementation of MIDAD system and service	MID States

The Workshop agreed that Phase A would have the main following advantages:

- a) Cost effectiveness including shared investments and resources
- b) Data Quality and Integrity
- c) Training
- d) Compliance with ICAO requirements and the European regulatory framework, including for an expeditious transition from AIS to AIM
- e) Technical solutions including system upgrades
- f) Interoperability
- g) System and Service security
- h) Back-up and Contingency

2.6 The Workshop developed the following Draft Action Plans for Phase A and Phase B. It was agreed that a detailed action plan for the implementation of Phase B (Set-up of MIDAD Manager) should be developed by the MIDAD Task Force.

2.7 The meeting may wish to recall that the DGCA-MID/4 meeting was provided with a progress report related to the MIDAD project and agreed on the way forward proposed by the EAD-MIDAD Workshop. The meeting agreed to the following Conclusion:

DGCA-MID/4 CONCLUSION 4/4 – MID REGION AIM DATABASE (MIDAD)

That:

- a) States are encouraged to engage with EUROCONTROL to migrate to the European AIS Database (EAD);
- b) a detailed action plan for the implementation of Phase B: "Set-up of MIDAD Manager" be developed by the MIDAD Task Force; and
- c) a progress report be presented to the DGCA-MID/5 meeting.

2.8 As a follow-up action to the DGCA-MID/4 Conclusion 4/4, the ICAO MID Office issued State Letter Ref.: AN 8/4.2.1-18/021 dated 21 January 2018, encouraging States to engage with EUROCONTROL to migrate to the European AIS Database (EAD); and provide their feedback related to State's plan and progress of the MIDAD Project Phase A (Migration to EAD). Four (4) replies were received from States, as at **Appendix A**.

# **3.** ACTION BY THE MEETING

3.1 The meeting is invited to:

- a) encourage States to engage with EUROCONTROL to migrate to the European AIS Database (EAD) (DGCA-MID/4 Conclusion 4/4 item a);
- b) review and provide update on the States' plan and progress for the MIDAD Project Phase A (Migration to EAD), at **Appendix A**; and
- c) agree on the way forward.
