1. Introduction

1.1 The MIDANPIRG/16 meeting noted with concern that the majority of deficiencies listed in the MANDD have no specific Corrective Action Plan (CAP). The meeting urged States to implement the provisions of MIDANPIRG Conclusion 15/35 related to elimination of Air Navigation Deficiencies, in particular, the submission of a specific Corrective Action Plan (CAP) for each deficiency.

2. DISCUSSION

2.1 The different MIDANPIRG Subsidiary bodies have reviewed the list of air navigation deficiencies related to their Terms of Reference (TORs) and agreed to the following:

RGS WG/4:

- The meeting reviewed and updated the list of deficiencies in the AOP field.

AIM SG/4 meeting:

- The meeting reviewed and updated the list of deficiencies in the AIM field. The meeting agreed that the elimination of the Deficiencies related to QMS implementation is a high priority and collaboration of States in this respect was strongly encouraged. Accordingly, in support of the NCLB initiative, the meeting noted with appreciation that Saudi Arabia, Sudan and UAE offered their support by inviting interested States to visit their AIS and share their experience, documentation and best practices.
- The meeting encouraged States to extend the invitation of training courses and workshops organized at National level to experts from other States/AISs, in close coordination with the ICAO MID Office.

ATM SG/4 meeting:

- The meeting reviewed and updated the list of deficiencies in the ATM and SAR fields. Taking into consideration that the signature of contingency agreements is a regional requirement in the MID Region and it is not mandated in the adjacent Regions, the meeting agreed that the signature of the contingency agreements with ACCs of the States at the interfaces with the ICAO MID Region be considered as "recommended" and not mandatory. Therefore, the meeting agreed that the deficiencies reported against the States at the interfaces for non-signature of contingency agreements should be removed. The MANDD has been updated accordingly.
- The meeting may wish to note that:
 - o the two (2) ATM deficiencies of Egypt related to ATS Routes are proposed for deletion, based on the outcome of the ATM SG/3 meeting.
 - o the two (2) SAR deficiencies of Qatar are proposed for deletion, based on the evidences provided to the ICAO MID Office by Qatar.

MET SG/7 meeting:

- The meeting reviewed and updated the list of deficiencies in the MET field. The meeting agreed that two new deficiencies related to the non-issuance of SIGMET in Damascus and Sana'a FIRs should be proposed.

CNS SG/8 meeting:

- The meeting reviewed and updated the list of deficiencies in the CNS field.
- 2.2 The lists of air navigation deficiencies as updated by the different MIDANPIRG subsidiary bodies and the Secretariat (based on inputs received from States) are at **Appendices A** to **F**.

3. ACTION BY THE MEETING

- 3.1 The meeting is invited to:
 - a) note and support the outcome of the MIDANPIRG subsidiary bodies with regard to the review and update of air navigation deficiencies; and
 - b) urge States to implement the provisions of the MIDANPIRG/15 Conclusion 15/35 and provide updates on the status of their deficiencies using MANDD.

Note:* Priority for action to remedy a deficiency is based on the following safety assessments:

'U' priority = Urgent requirements having a direct impact on safety and requiring immediate corrective actions.

Urgent requirement consisting of any physical, configuration, material, performance, personnel or procedures specification, the application of which is urgently required for air navigation safety.

'A' priority = Top priority requirements necessary for air navigation safety.

Top priority requirement consisting of any physical, configuration, material, performance, personnel or procedures specification, the application of which is considered necessary for air navigation safety.

'B' priority = Intermediate requirements necessary for air navigation regularity and efficiency.

Intermediate priority requirement consisting of any physical, configuration, material, performance, personnel or procedures specification, the application of which is considered necessary for air navigation regularity and efficiency.

Definition:

A deficiency is a situation where a facility, service or procedure does not comply with a regional air navigation plan approved by the Council, or with related ICAO Standards and Recommended Practices, and which situation has a negative impact on the safety, regularity and/or efficiency of international civil aviation.
