Scope

ICAO Annex 15 Amendments:

- AMDT 39-A: SATVOICE, runway end safety area, applicable 10-Nov-2016
- 2. AMDT 39-B : SNOWTAM format change, applicable 05-Nov-2020
- AMDT 40 : Data Catalogue and AIP data sets, applicable 18-Nov-2018



Impact Analysis for Amdt 39-A



Technical impact:

- EAD database
- eAIP application

Operational impact:

- No impact on EAD procedures
- EAD AIP Training Workbook must be updated accordingly

Impact Analysis for Amdt 39-B



Technical Analysis: EAD INO application must be adapted (INO DP & INO DU)

SNOWTAM creation:

- Interfaces (ECIT, ESI, AIMSL)
- Changes in validation rules
- Changes in text generation for distribution

SNOWTAM processing:

- Parsing of incoming messages
- Changes in validation rules

Operational Analysis:

- Adaptation of operational procedures
- Update of training documentation



Impact Analysis for Amdt 39-B



Risk: Not all States might be ready on time with the new format

- EAD Operational Transition:
 - Transition period where EAD will accommodate both formats
 - Evaluate Translation capability from "New to Old" and from "Old to New" before and after 5th Nov 2020?



Impact Analysis for Amdt 39-B

Risk: Not all states might be ready on time with the new format

- Coordination with and assistance to EAD customers for their implementation of the SNOWTAM format changes
 - Set up a project and create a dedicated WG, where States, ANSPs and airspace users will share & discuss common issues and difficulties encountered during implementation
 - Potential update of
 - EUROCONTROL SNOWTAM Guidelines (needed?)
 - OPPAD



Impact Analysis for Amdt 40



Analysis is ongoing

Initial impact on:

- Implement the Eurocontrol Specifications for data sets
- Data sets production
 - Allow DP to produce digital data sets
 - Upgrade eAIP application
 - Enable provision through PAMS
- Potential impact on EAD Data Catalogue
- Training documentation
- EAD Client Agreements
