Subject: PBN OPS Approval Course (Beirut, Lebanon, 26 - 30 November 2018)

Action required: Reply not later than 25 October 2018

Sir,

I have the honour to invite your Administration/Organization to participate in the PBN OPS Approval Course that will be held in Beirut, Lebanon, from 26 to 30 November 2018, as part of the initiation phase of the ICAO MID Region Flight Procedure Programme (MID FPP). The Course is thankfully hosted by the Lebanese Directorate General of Civil Aviation.

The course will be delivered by IATA, free of charge, (*instead of US\$3100 per participant*) as an in-kind contribution to the MID FPP and the ICAO MID Region. However, participants are responsible for their own travel arrangements, including hotel reservations, as well as travel and medical insurance.

The Course addresses the Performance-Based Navigation PBN approval process from the perspective of the State regulator as well as the air operator. Air operators will learn how to apply for the operational approval and what tasks are required in each of the five steps of the process. State regulators, will learn how to guide the air operator through the operational approval process. ATC will understand the requirement allowing the air operators to use the PBN procedures for consideration during the planning and implementation phases. The targeted audience is a mix of pilots and regulators involved in the PBN approval process as well as procedure designers and ATC.

The Course Schedule and the Bulletin that includes administrative arrangements for the course and other useful information for participants are at **Attachment A** and **B**, respectively.

Considering the limited number of seats, I would appreciate if you could, as soon as possible, preferably not later than **25 October 2018**, provide the ICAO MID Office with the names of **two (2)** candidates, by sending the Nomination Form at **Attachment C** to (<u>icaomid@icao.int</u>) with a copy to (<u>ekhoury@icao.int</u>).

I would like to draw your attention that nominations will be accepted on the basis of availability "first-come, first serve". However, acceptance of additional trainees could be considered at later stage based on the remaining available seats.

1. LOCATION

1.1 The PBN OPS Approval Course will be held in Beirut, Lebanon, from 26 to 30 November 2018, as part of the initiation phase of the ICAO MID Region Flight Procedure Programme (MID FPP). The Course is thankfully hosted by the Lebanese Directorate General of Civil Aviation.

1.2 The Course will be delivered by IATA, free of charge, as in-kind contribution to the MID FPP and the ICAO MID Region.

2. SCHEDULE OF THE MEETING

- 2.1 The opening session of the Course will be held at 08:00 hours on Monday, 26 November 2018.
- 2.2 The schedule and order of the day will be announced at the opening session.
- 2.3 The Course will be conducted in English.

3. **REGISTRATION OF PARTICIPANTS**

3.1 Participants are requested to register, at the Registration Desk located at the entrance of the designated conference room, between 07:30 and 08:00 hours on the opening day of the Course. Participants are also requested to wear the Identification Badge which will be issued to them during registration.

4. DOCUMENTATION

4.1 Please note that no documentation will be available in hard copy format. However, documentation related to the Course will be provide on the first day. Accordingly, participants are requested to bring along their laptops to be able to download the course materials.

PASSPORT/VISA

8.1 All foreign nationals entering Lebanon must possess valid passports or other valid documents for travel. Documents with less than six months to run before expiry are not acceptable.

8.2 For information on the Entry Visa to Lebanon, participants are invited to check the Lebanese General Security Website <u>http://www.general-security.gov.lb/en/posts/38</u>, or consult the Lebanese Embassy/Consulate in their respective countries.

8.3 DGCA will provide necessary assistance for the issuance of entry Visas for the delegates, when needed.

9. CURRENCY, CREDIT CARDS AND BANKING SERVICES

9.1 The unit of currency in Lebanon is the **Lebanese Pound (LBP)**. The unit is divided into 1000 Lira with notes of 100, 250, 500, 100, 5,000, 10,000 and 100,000 Liras 50. The USD to LBP exchange rate is around 1 US = 1505 LBP.

9.2 International Credit Cards, such as American Express, Diners Club, Visa, Master Card, Carte Blanche, etc. are usually accepted at most hotels, department stores and restaurants.

9.3 All commercial banks exchange major foreign currencies are open from 0800 to 1400, Sundays through Thursdays. There are also plenty of foreign exchange houses who do accept foreign currency. There are plenty of ATM machines all over Lebanon which are strategically located. Moreover, payments with US\$ is accepted in Lebanon (no need to exchange to LBP).

10. OTHER USEFUL INFORMATION

10.1 A large variety of shopping choices are available in Grand Shopping Centers, Malls and Hypermarkets including all goods and demands that range from necessary stuff to luxurious ones.

11. WEATHER CONDITIONS

11.1 The main daily minimum and maximum temperatures for the month of November in Lebanon are between 15 °C and 25 °C. You may also wish to check the weather forecasting prior to travel.

12. OTHER ASSISTANCE

12.1 The Directorate General of Civil Aviation in Lebanon (DGCA) will be glad to assist the participants to the Course with any advice they may require.
