





## Impact of COVD-19 on Travel & Tourism (Globally and by Region)








## Estimates of Time for recovery of the Global Economy from COVID-19 Crisis








# Estimates of Time for Recovery of the Arab World Economy from COVID-19 Crisis








## Estimates of Time for Tourism Recovery in the Arab World from COVID-1 Crisis








# Impact on Airport Revenues & Operations








## AACO Members Fleet Status During Different Phases of the COVID-19 Crisis

Arab Civil Aviation Organization Level

In the framework of coordinating Arab efforts to return to the normal operation of civil aviation activities, the Arab Civil Aviation Organization took the following measures:

#### Latest developments and measures taken on **Arab Civil Aviation Organization Level (1/4)**



- Coordinating the positions of member states regarding common issues interest and urging airlines and governments to work together to reduce the impact of CORONAVIRUS-19 pandemic by creating a platform on the Arab Civil Aviation Organization website concerned with:
  - Collecting data on this epidemic
  - Collecting the operational and guidelines measures taken and shared with States.
  - Circulate to states the best practices applied.
  - ▲ Inventory of the current needs of countries with the aim of developing a plan for the post-pandemic stage, i.e. the stage of recovery,
  - Collecting official data and statistics related to the impact of the pandemic on this sector.
  - Provide a table for attendance officials in Arab Civil Aviation Authority to ease pordination

3. Urging member states to be guided by the necessary procedures, as stated in all annexes, instructions and documents related to health crisis management, with the aim of restoring the air traveler's confidence in ensuring that they are not exposed to infection during the travel trip, and also urging countries to use the guidance being developed by CART TF.



### Latest developments and measures taken on Arab Civil Aviation Organization Level (4/4)



- 5. Urging Member States to inform ICAO of any temporary discrepancies that may result from the emergency measures taken to address the COVID-19 virus, particularly those related to certification, licensing and provision of certificates through the CCRD subsystem via the EFOD Performance Dashboard.
- 6. Urging the member states, that have not yet joined, to join the CAPSCA program.

### Latest developments and measures undertaken at Regional and International levels (1/10)



1 - Meetings with the International Civil Aviation Organization at the ICAO Headquarters level, at a bi-weekly basis (COVID-19 Outbreak Technical meeting)

2-Meetings with the Council Aviation Recovery Task Force (CART) established at the ICAO Council level

3-Participation to international seminars, especially those related to:

- ✓ the ICAO Council Aviation Sector Recovery Task Force (CART) report and documentation, as well as the implementation plan
- ✓ the new ICAO website on the CRRIC COVID-19 Response and **Recovery Implementation Center**



## Latest developments and measures undertaken at Regional and International levels (2/10)



- 2- Coordination with the Arab Tourism Organization and the Arab Air Transport Association, to establish a task force to:
- manage the crisis,
- consider practical measures and plans that would support the return of normal operation and encourage Arab governments to adopt them upon the exit from the crisis,
- follow the crisis and find related solutions

This TF includes a number of ministers and highranking personalities from the three organizations

### Latest developments and measures undertaken at Regional and International levels (3/10)



3- Communication with international and regional organizations and with member states by exchanging information and procedures supporting states to expedite the recovery phase and return to normal situation activities

4- Attending and participating in a high-level regional meetings in the Middle East region, involving International and regional Organizations (ICAO, IATA, CANSO, ACI, IFALPA, IFATCA, AACO, etc.,) on managing the COVID-19 crisis

5. Organizing a joint workshop with Arab civil aviation authorities, ICAO, IATA and AACO to discuss the indicators that help in restoring the operation of air transport, recovering the industry, and restoring the confidence of the air traveler

10- Attending to the 33<sup>rd</sup> session Council of Arab Transport Ministers meeting where adopted resolution no. 488, by which the Council welcomed the approach of opening borders between states based on the risk of transmission of the virus: It was sent to ACAO State members and ICAO for consideration

and support,





### Latest developments and measures undertaken at Regional and International levels (9/10)



#### This approach consists of:

- ✓ Each state would do its own assessment of the level of risk of transmission of the virus.
- ✓ CART could provide states with guidance on how to specify that level of risk and would associate it with a code of color which criteria could be agreed upon under CART.
- ✓ The criteria could be based on number of cases per number of tests taken during
  a specific period of time, the percentages of positive results, the number of tests
  done, and other elements that could be agreed upon via consultation with states,
  health authorities and relevant organizations.

## Latest developments and measures undertaken at Regional and International levels (10/10)



#### This approach consists of:(con't)

- ✓ Once the criteria are agreed upon, CART would receive the relevant data from states periodically and update the color codes of states.
- ✓ CART would publish the color code of each state on a global public map to be viewed and used by states.
- ✓ Biosafety measures associated with each color-code would also be agreed upon by CART via wide consultation with states, health authorities and stakeholders.
