The Webinar is co-organized by the ICAO MID Regional Office and the World Food Programme (WFP) in close collaboration with other aviation partners/stakeholders.

WFP co-hosted several Aviation Safety Campaigns (ASC) worldwide as part of its commitment in taking actions to reduce risk and prevent aviation accidents. The objective of the Webinar is to raise awareness about the humanitarian operations and the need to have regional coordination and communication at the time of crisis and during disasters. This ASC is planned to address important issues related to:

- the crucial need to have healthy communication between all stakeholders through Regional Cooperation in Times of Crisis; and
- addressing the unrivalled implication of the Pandemics and showcasing some of the best practices for business continuity during the pandemic.

The detailed Work Programme of the Webinar will be provided in due course. At the end of the Webinar, there will be a Question and Answer (Q&A) Session, which will provide the opportunity to all stakeholders to engage in developing the foundation to address various mutual safety challenges and issues faced, as well as embark on a gradual regional approach towards the COVID recovery/restart efforts.

Accordingly, it is strongly recommended that States encourage attendance of Ministry of Transport/Civil Aviation officials, Civil Aviation Authority personnel who deal with public health emergency preparedness planning, including Airport, Air Navigation Service Providers, Airline representatives, and other Stakeholders as relevant.
