I have the honour to inform you that the second MID ASBU Webinar will be held on 19 - 20 January 2021. Details on the exact timing of the sessions will be provided at a later stage. Your Administration/ Organization is kindly invited to participate in this Webinar.

You may recall that the 7th meeting of the MIDANPIRG Steering Group (MSG/7) held virtually from 1 to 3 September 2020, agreed, through MSG Conclusion 7/6, that the joint ACAO/ICAO ASBU Symposium review the inputs of States, Stakeholders and MIDANPIRG Sub-Groups for consolidation of the revised version of the MID Region Air Navigation Strategy to be presented to MIDANPIRG/18 for endorsement, in February 2021. Due to the continuous COVID-19 outbreak, the face-to-face Symposium is replaced by a Webinar.

The main objective of the Webinar will be to review the consolidated revised version of the MID Region Air Navigation Strategy based on all received inputs and make final adjustments, as deemed necessary. The Webinar will also review the inputs of the MIDANPIRG Sub-Groups and States related to the selected MID AN KPIs to be monitored at National and Regional levels; and recommend what to be proposed to MIDANPIRG/18 for endorsement.
