
Technical Assistance Activities-Progress Report on the Implementation of MID Region NCLB Strategy







- The ICAO No Country Left Behind (NCLB) initiative, which was launched in December 2014, aims at providing support to all States and in support of the five ICAO strategic objectives, for the resolution of significant safety concerns (SSCs) and significant security concerns (SSeCs) and for an effective implementation of ICAO's SARPs, policies, plans and Programmes, in a globally-harmonized manner; promoting and implementing all ICAO's assistance activities.
- In support to the ICAO "No Country Left Behind" (NCLB) Initiative and the Assembly Resolution A39-23, the DGCA-MID/4 meeting, through Conclusion 4/1, endorsed the MID Region NCLB Declaration (Muscat Declaration) and the DGCA-MID/5 meeting, through Conclusion 5/7-endorsed the MID Region NCLB Strategy (Second Edition).







ICAO NCLB Initiative

- **Reflects** ICAO's current mandate and operations
- For ALL States and ALL Strategic Objectives
- Focus on increased State implementation of ICAO policies, plans and SARPs and enhanced ICAO support for States with prioritized needs
- Raise awareness on the importance and benefits of improved global air connectivity and aviation system access for sustainable growth, development and socio-economic prosperity







MID NCLB Strategy- Prioritization of States in Safety

MID States are classified in four (4) groups, as follows:

- 1. States with SSC;
- States not audited or with EI below 60% (EI < 60);
- 3. States with EI between 60 and 70% ($60 \le EI < 70$); and
- 4. States with EI over 70% (EI \geq 70).

Additional Prioritization Criteria:

- State willingness/commitment to receive assistance;
- Security and political stability;
- El per Area and per Critical Element (CE);
- Level of aviation activities in the State;
- Air navigation deficiencies;
- Level of progress made by State in the development and implementation of Corrective Action Plans (CAPs);
- Gross Domestic Product (GDP) per capita; and
- Ongoing or planned assistance projects.

 - ✓ the second Steering Committee meeting was held in Abu Dhabi, UAE during 15 16 June 2022. where the Committee agreed on the funding mechanism and the Work Plan for Y2022.
 - Pool of Experts: in total Eight (8) specialists from Iran (4), Oman (1) and UAE (3).
