1. WP objective

 This WP presents guidance material and share best practices to support inspectors of the competent national authorities of ICAO member States intending to address the regulatory, technical and operational aspects of conducting oversight to ensure safe transport of Dangerous goods by air is within prescribed parameters of acceptance and handling by aircraft operators and freight forwarders (hereafter referred to as DG agents)


Dangerous Goods Inspector training and Qualifications

- Minimum professional qualifications shall be established and implemented
- DG Inspector is provided with:
 - the technical and administrative training
 - the opportunity to continually develop their knowledge and skills
 - the resources required to undertake necessary training
- Necessary training shall include: Initial, recurrent, OJT and specialized and recommended training
- Recurrent training, refresher or periodic training, covers and reviews elements of the initial training programme and should be scheduled over a cycle of not more than 5-years and depends on the periodicity of the training.









Establishment of Dangerous Goods Training Programme

Note: Security personnel who are involved with the screening of passengers and crew and their baggage and cargo or mail are required to be trained irrespective of whether the operator on which the passenger or cargo is to be transported carries dangerous goods as cargo.

- The aim of inspecting information provided for passengers is to ascertain those operators (or their agents) are providing such information
- The inspection should confirm that notices are at the required places (check-in desks, ticket sales desk and operator-maintained aircraft boarding areas including websites)
- The method of inspecting warning material in or with tickets is to ask to look at passenger's tickets or during the web based online check-in portals to be demonstrated by the operator.








