## 1. Introduction

- 1.1 The Preamble to the Convention on International Civil Aviation (Doc 7300, Chicago Convention) highlights that States, parties thereto, "agreed on certain principles and arrangements in order that international civil aviation may be developed in a safe and orderly manner and that international air transport services may be established on the basis of equality of opportunity and operated soundly and economically".
- 1.2 Article 3 of the Chicago Convention provides that it shall be applicable only to civil aircraft and shall not be applicable to state aircraft, which are used in military, customs and police services as per Article 3 b). However, Article 3 d) requires that "contracting States undertake, when issuing regulations for their state aircraft, that they will have due regard for the safety of navigation of civil aircraft".
- 1.3 Therefore, there is a need for States to establish a framework for ensuring adequate collaboration, cooperation and coordination between civil and military aviation stakeholders, aiming to support States to fulfil their national requirements and meet their obligations as parties to the Chicago Convention. The focus of ICAO Doc 10088 is to provide guidance to States wishing to implement or improve civil-military cooperation for air traffic management, for the safe and optimal use of the airspace by both parties. It is important to note, however, that most of this material would be equally relevant to the wider spectrum of state aircraft operations, as well as other airspace usage.

- 1.4 Civil and military operations differ in nature and in purpose. While civil aviation supports global interconnection and contributes to the global economy, military operations are conducted for reasons of national security or defence. However, both types of operations take place in a single continuum of airspace and, therefore, civil aviation and military stakeholders need to cooperate to ensure their mutual safety. Successful cooperation is based on mutual trust, respect, transparency and understanding. Additionally, the modernization of air traffic management (ATM) towards greater information flows and operational flexibility creates a need to enhance civil-military cooperation and coordination.
- 1.5 Notwithstanding civilian requirements, militaries also need to use airspace effectively and efficiently while conducting their operations. States are encouraged to foster better civil-military cooperation to meet the increasing need for access to airspace by both types of actors, alongside the growing need for operational flexibility.

#### 2. DISCUSSION

- 2.1 The ICAO Civil-Military Cooperation Workshop was held in Tehran, Iran, from 16 to 18 May 2022. More than 130 participants from Civil Aviation Authority (Iran CAA), Military and Iran Airports and Air Navigation Company (IAC) participated in this workshop.
- 2.2 Based on the update provided by ICAO concerning the ICAO provisions related to Civil-Military collaboration, cooperation and coordination as well as the outcome of the hands-on exercise, the Workshop agreed on the followings:
  - a) recognized the need for enhancing the open dialogue between Civil and Military stakeholders to agree on high-level policy and procedures required for civil-military cooperation;
  - b) emphasized that the current framework would require changes, including representation aspects and the processes used for coordination between the parties at the high-level and at the level of the ASM Committee;
  - c) noted that it is time that a review be carried out for the optimization of the airspace including the use of temporary reserved areas in accordance with Doc 10088, taking into account the Iran objectives related to safety, security, economy, defence, capacity and efficiency.
  - d) appreciated the excellent level of cooperation and communication demonstrated between all participants, especially during group exercises;
  - e) took note of the aviation system and the civil-military arrangements in place;
  - f) encouraged Iran to proactively improve the civil-military cooperation framework in accordance with the guidance of the Manual on Civil-Military Cooperation in Air Traffic Management (Doc 10088) to ensure effective collaboration, cooperation and coordination and, in particular:
    - i. the establishment of a high-level Civil-Military Aviation Cooperation Policy Board (CMAB) and a Committee for Airspace Organization and Management (CAOM);
    - ii. the improvement of tactical coordination taking into consideration the need for setting up an airspace management cell (AMC); and
    - iii. the implementation of flexible use of airspace (FUA); and
  - g) expressed its commitment to follow-up on the progress and provide guidance and support as required through the ICAO MID Regional Office.

2.3 In performing the objectives in paragraph 2.2, items "f" & "g", Iran CAA with participation of all relevant stakeholders and support of ICAO MID Office developed required action plan at **Appendix A** in line with ICAO guidance material Doc 10088 to implement Civil and Military Cooperation (CMC), Flexible Route of Airspace (FUA) and Free Route Airspace (FRA) concept in Tehran FIR.

## 3. ACTION BY THE MEETING

- 3.1 The meeting is invited to:
  - a) review action plan at Appendix A and provide feedback, if any;
  - b) MID States share their experience and knowledge regarding successful implementation of CMA, FUA & FRA with other States; and
  - c) ICAO MID office to support Iran CAA to achieve the objectives in paragraph 2.3.
