Continue Incorporating Preparedness Planning in Public Health and Aviation Sector into national All - Hazard Preparedness and Response Framework for Communicable Diseases

Continue prioritizing the review/ updating of their National Aviation Public Health Emergency Preparedness Plan (NPHEPP),

Consider the acceptance of Antigen RDT (with minimum sensitivity & specificity of 95%) for screening test at the Point of Entry.

Ensure that the Collaboration, between the Public Health Authority (PHA, CAA and other major stakeholders

Consider accepting Proof of recovery from COVID-19 infection as alternative for vaccination.

Consider the continued strengthening of National Air Transport Facilitation committee

Ensure that the gains (Capacity building) recorded during the COVID-19 Pandemic are sustained

Consider the acceptance of Antigen RDT (with minimum sensitivity & specificity of 95%) for screening test at the Point of Entry

Continue investing in PHC-iPack courses and CAPSCA technical assistance technical advisor courses

Consider having a Follow-up CAPSCA Technical Assistance visit

Consider the use of ICAO Visible Digital Seal (VDS) in their Vaccination certificate of Travel

Harmonization of Risk Mitigation Measures between the States

Engaging in bilateral discussion to establish public health corridors between the two States
