1.1 The Nineteenth Meeting of the Middle East Air Navigation Planning and Implementation Regional Group and the Ninth Meeting of the Regional Aviation Safety Group-Middle East (MIDANPIRG/19 & RASG-MID/9) were held in Riyadh, Saudi Arabia from 14 to 17 February 2022.
