






Structuring the Civil Aviation Authority for the Air Accidents bureau


The structure of the Ministry of Transportation for the Air Accidents Investigation BUREAU

Responsibilities of the Aircraft Accidents and Incidents Investigation BUREAU



- Formation of investigation committees into aircraft accidents and incidents.
- > Follow-up of procedures for investigation of aircraft accidents and incidents.
- ➤ Studying and analyzing the results of aircraft accident investigations to benefit from them in developing programs and action plans to avoid future aircraft accidents.
- ➤ Preparing and developing a database on accidents and incidents that occur in Libya and the aircraft registered there
- ➤ Participation in investigations that occur on aircraft registered in Libya or aircraft operated for
 - a Libyan carrier.
