ICAO Audit on EGYPT



Background

Under the Comprehensive Systems Approach (CSA), the last audit done was:

- Date: 23 November to 4 of December 2014
- The audit generated: 394 Unsatisfactory PQs/Findings .
- Effective Implementation (EI): 56.08 %

There was a Technical Assistance received from ICAO Mid regional office during Feb. 2016 which was very useful for ECAA before ICAO ICVM audit.



Background (Cont.)

ICAO Coordinated Validation Mission (ICVM) under the USOAP CMA:

- Date: 20 to 29 November 2016
- The scope of ICVM covered (LEG, ORG, PEL, AIR, OPS, ANS and AGA) areas
- AIG was not assessed.
- 373 unsatisfactory PQs were assessed and their progress reviewed
- 255 PQs status changed to satisfactory
- The effective implementation (EI) improved from 56.08 % to 83.57% according to ICVM Report
- Due to a revision in Protocol Questions, The effective implementation was changed to 84.38 % according to CMA OLF.

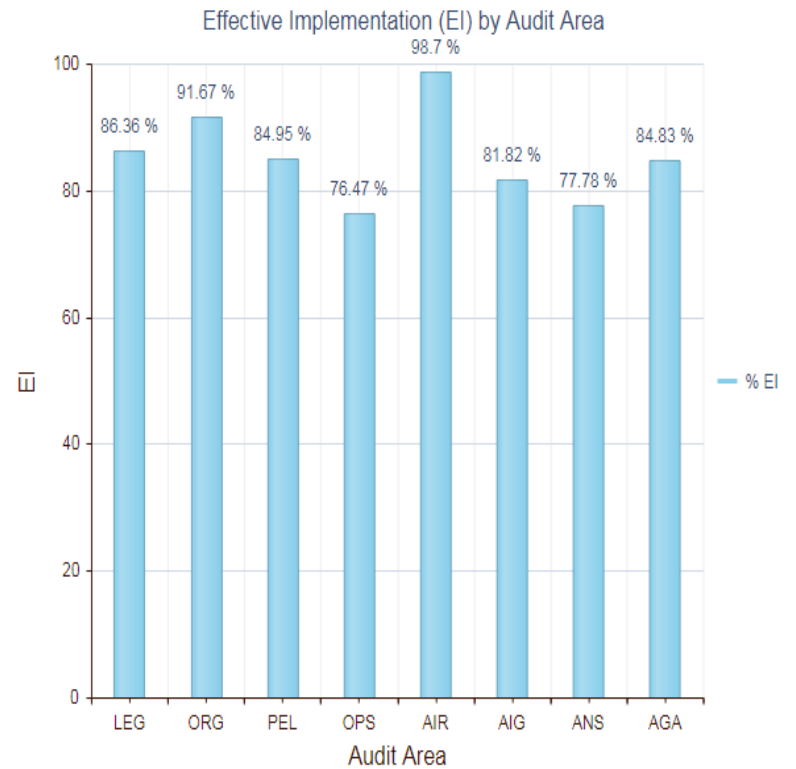
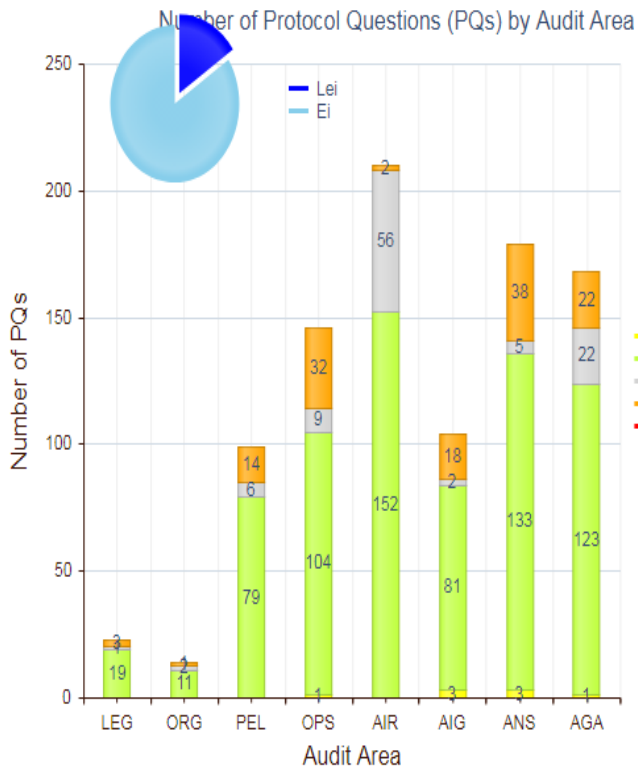
