ECAA established an emergency response plan in coordination with Public Health Authority and other stakeholders.

Following recommendations and periodic instructions issued by ICAO and WHO.

This plan is in continuous observation, follow up and control process .

- The Egyptian Quarantine Department is the oldest in the Middle East and Africa.
- Quarantine measures at POE according to :
- National Law No. 44 of 1955 Concerning Quarantine Procedures and its Amendments.
 International Health Regulation 2005 (IHR)
- International Health Regulation 2005 (IHR)

- In Egypt we have a total of 38 Points of Entry, from which only 19 PoE are designated according to the IHR(annex 1- b) core capacity requirements.
- * Airports: (8)
- * Eight (8) designated Airports :
- * Cairo Airport, Sharm El-Sheikh Airport, Hurghada Airport, Borg El-Arab Airport, Asiut Airport, Sohag Airport, Luxor Airport & Aswan Airport.
- * Seaports: (8)
- * Eight (8) designated Seaports :
- Suez Seaport, Alexandria Seaport, Port-Saeed Seaport, Nuweiba Seaport, Dameyatta Seaport, Safaga Seaport, Hurghada Seaport & East High Dam Nile port.
- * Ground Crossings: (3)
- * Al-Salloum Ground Crossing & Kostol Ground Crossing & Argeen crossing.












Crisis Managment And Updates Of Activities IHR Core capacities for routine operations at designated point of entry PoE

- Circular no 5 of 2022 from Ministry Of Egyptian Public Health updating entry requirements for coronavirus:
- As part of the Egyptian efforts to facilitate entry procedures, work to streamline passenger movement and prevent crowding in the arrival halls, all travel restrictions for entry have been cancelled.

Egypt requirements at Point of Entry:

- * Countries with risk of yellow fever transmission
- Africa: Angola, Benin, Burkina Faso, Burundi, Cameroon, Central African Republic, Chad, Congo, Côte d'Ivoire, Democratic Republic of the Congo, Equatorial Guinea, Ethiopia, Gabon, Gambia, Ghana, Guinea, Guinea-Bissau, Kenya, Liberia, Mali, Mauritania, Niger, Nigeria, Senegal, Sierra Leone, South Sudan, Sudan, Togo and Uganda.
- America: Argentina, Bolivia, Brazil, Colombia, Ecuador, French Guyana, Guyana, Panama, Paraguay, Peru, Suriname, Trinidad, Tobago and Venezuela.

Egypt requirements at Point of Entry:

Vaccination certificate is required against yellow fever for travelers to Egypt (9 months or over) in the form of an international vaccination certificate as specified in Annex 6 of the IHR, and for travelers having transited for more than 12 hours in an airport of a country with risk of yellow fever transmission.

Countries with risk of poliovirus Afghanistan - Malawi - Mozambique - Pakistan - Madagascar -Democratic Republic of the Congo.

All residents and long-term visitors (more than 4 weeks) to countries with the potential risk of international spread of polio virus, receive a dose of bivalent oral poliovirus vaccine (bOPV) or inactivated poliovirus vaccine

IPV) vaccine between 4 weeks and 12 months prior to traveling to Egypt.

An International Certificate of Vaccination is requested in the form specified in Annex 6 of the IHR to record their polio vaccination and serve as proof of vaccination.
