1. Introduction

1.1 The 14th E/CAR DCA Meeting, held in San Juan, Puerto Rico from 9 to 12 June 1998 formulated the latest rotational list of sites for the E/CAR Directors of Civil Aviation Meetings. The agreed meeting host rotation programme is included in **Appendix A** to this paper.

1.2 According to the approved meeting host rotation programme, an OECS State was to host the 18^{th} Meeting in 2003. Thanks to a proposal received from Trinidad and Tobago, this Meeting has been convened in Port of Spain. **Appendix B** presents the actual historical list of hosts for E/CAR DCA Meetings up to date.

APPENDIX A

CONCLUSION 14/9 SITES OF DCA MEETINGS

That,

- a) beginning with the 15th DCA E/CAR Meeting, the host of the yearly DCA meetings should follow successively this rotational list, with each entity determining the actual site of the meeting:
 - OECS
 - French Antilles
 - Trinidad and Tobago
 - OECS
 - Barbados
 - USA
 - British Virgin Islands;
- b) the other States and International Organizations normally invited to participate in the E/CAR DCA meetings can at any time offer to host a DCA meeting: Aruba, Guyana, Netherlands Antilles, Suriname, Venezuela;
- c) should a State not be able to host a particular DCA meeting, the ICAO NACC Office should be advised at least 6 months before the convening of the meeting, where upon the next State on the rotational list should take on the responsibility of hosting that meeting; and
- d) the E/CAR Working Group develop its own rotational list for its meetings, taking into consideration the E/CAR DCA rotational list shown in paragraph a).
