REPORT OF COORDINATION MEETING BETWEEN CHAIRMEN OF SUB-GROUPS

(Presented by the Chairmen of the ATMAIS/SAR SG and CNS/MET SG)

SUMMARY

The chairmen of the ATM/AIS/SAR SG and CNS/MET SG held a coordination meeting on 23 August 2004. The meeting was attended by supporting member of the Secretariat and received input from the Chairman of the RASMAG. This paper details issue discussed.

1. INTRODUCTION

The APANPIRG Procedure Handbook (9.2) provides for the meeting of the chairpersons of the Sub Groups for the purpose of coordination. The Chairmen of the ATM/AIS/SAR SG and CNS/MET SG held a coordination meeting on 23 August 2004. Comment was also sought from the chairman of the RASMAG. The supporting members of the Secretariat also participated in the meeting.

The following paragraphs provide details of issues discussed.

2. DISCUSSION

2.1 AIDC

The implementation of AIDC was discussed in both forms of AIDC using AFTN and AIDC using ATN. The need for performance monitoring was discussed analogous to the performance monitoring CPDLC data link communications. The difference was AIDC is between two centres whereas CPDLC is between centres and a multitude of aircraft. The need for AIDC performance monitoring was considered to be within the portfolio of RASMAG.

2.2 ADS-B

Concern was express on the current technical focus of the ADS-B Study and Implementation Task Force. It was pointed out that the ADSBSITF is multidiscipline and States should be nominating an appropriate balance of experts to the TF. The TF has been established by APANPIRG and reports to both sub-groups.

2.3 ATM/MET

The MET/ATM Task Force reporting to the CNS/Met SG was acknowledged as forum for the exchange for information between ATM operational specialist and meteorologist. Activities of the MET/ATM TF include a survey of States on meteorological operational information. Concern was expressed about coordination of issues such as large scale weather deviation quoting the Bay of Bengal and the South China Sea as example areas. This particular issue is being addressed by Headquarters and will result in SARP amendments.

2.4 Task Forces and Other Contributory Bodies

The meeting reviewed the collation of task force and other contributory bodies to APANPIRG. This list is presented in the attached to this paper. The purpose was to ensure that task forces where being operated in compliance with the Procedural Handbook and that when the task force has completed it work or was in a situation that it was unable usefully continue its task the task force should be dissolved.

Based on the review the following decision has be drafted.

Draft Decision 15/x - Dissolution of Tasks Forces and Other Contributory Bodies That,

the following task forces and other bodies previously established by APANPIRG or one of it Sub Groups be dissolved as the task force or other body has completed its task or it is unable usefully continue its task.
