#### A GUIDE TO SUBMITTING DIFFERENCES TO ANNEX 9

(Presented by the Secretariat)

#### 1. **INTRODUCTION**

- 1.1 Whenever the ICAO Council adopts an amendment to an Annex, the Organization sends a "State letter" to all its Contracting States notifying them of the amendment and inviting them to take action on it.
- 1.2 The letter consists of three parts:
  - a) the *Letter* itself, that briefly describes the salient points of the Amendment, and provides deadlines for State action;
  - b) an *Attachment A* that is to be used if States wish to notify ICAO of any disapprovals to the amendment or any part of it; and
  - c) an *Attachment B* that is to be used if States wish to notify ICAO of their compliance with, or differences from, Annex 9.

### 2. **COMPLIANCE/DIFFERENCES**


- 2.1 Two flowcharts are attached to this paper as Appendix A. The first explains the steps that a State should take if it wishes to notify ICAO whether its national practice complies with or differs from an amendment to the Annex (*vis-à-vis* "Attachment B" referred to above, which is also attached to this paper as Appendix B, for ease of reference). The second chart describes the process using, as an example, Standard 3.10 of Annex 9.
- 2.2 The relatively straightforward "disapprovals" process (notification of which is made in the "Attachment A" appended to the pertinent State letter) is not described.


