SEVENTH ATN TRANSITION TASK FORCE MEETING

(Presented by the Secretariat)

SUMMARY

This paper reviews the work accomplished by the Seventh ATN Transition Task Force Meeting held in Shanghai, China from 18 to 22 April 2005 and presents draft Decisions and Draft Conclusions developed by the meeting for review and consideration.

1. INTRODUCTION

1.1 The ATN Transition Task Force established by APANPIRG/9 in 1998 addresses ATN Transition issues and also to deals with residual AFS issues. The Task Force reports its activities to APANPIRG through the CNS/MET Sub-Group. This paper presents the work accomplished by the Seventh Meeting of the Task Force. 2. DISCUSSION

2.1 The Seventh ATN Transition Task Force Meeting, hosted by the Air Traffic Management Bureau (ATMB) of the General Administration of Civil Aviation of China (CAAC) was held in Shanghai, China from 18 to 22 April 2005. The meeting was attended by 52 participants from twenty States: Australia, Bangladesh, Brunei Darussalam, Cambodia, China, Hong Kong China, DPR Korea, Fiji, India, Indonesia, Japan, Malaysia, Mongolia, New Zealand, Philippines, Republic of Korea, Singapore, Sri Lanka, Thailand, United States and Vietnam. The meeting formulated 9 Decisions, 2 draft Decisions and 9 Draft Conclusions for consideration by this meeting and APANPIRG/15 meeting.

2.2 The meeting considered 8 Information Papers and 29 Working Papers. The meeting, among others, developed 1 proposal for amendment of the CNS Part IV of the ASIA/PAC FASID and developed AMHS/MTA Routing Policy and updated AMHS Addressing Scheme and AMHS Naming Plan. The meeting also updated the ATN Documentation Tree.

2.3 Considering that most of the tasks had been completed by the Task Force, the meeting proposed to dissolve the ATN Transition Task Force and to establish an ATN Implementation Co-ordination Group and formulated two Draft Decisions for consideration by APANPIRG.

3. ACTION BY THE MEETING

The meeting is expected to:

- a) review the report the Seventh Meeting of the Task Force; and
- b) review the draft Decisions and draft Conclusions developed by the meeting under relevant agenda items and formulate recommendations for consideration by APANPIRG/16.
