1. Background

- 1.1 The ICAO NACC Regional Office website was originally published in 2000 to provide States/Territories/International Organizations and the general public with basic information on ICAO, and more specifically this Regional Office.
- 1.2 From the beginning, improved functionality has been considered in accordance with the evolution of electronic media for the optimization of resources and timely presentation and availability of information. This being considered, the site has been used for the publication of documentation for meetings, seminars and workshops; the introduction of electronic documents to be downloaded (e-Documents); the inclusion of the GREPECAS Air Navigation Deficiencies Database (GANDD); general information for Mexico City visitors; and recently, the publication of the Radio Frequency Assignment Lists CAR Region.

2. Considerations for the new website

2.1 This new website will be a link and a tool for the exchange of information and to coordinate relevant air navigation events for the NAM/CAR Regions. In addition to the current sections, the site will be enhanced with new sections for the exclusive use of States, Territories and International Organizations (protected with username and password*), as well as new public sections that include useful and relevant information such as:

- NACC State Letters (EMXs)*
- Scheduled events
- Registration forms for events
- Discussion forums *in development for 2009*
- Meeting Photo Gallery
- ICAO NACC Monthly Reports*
- What's new
- Air Navigation Section*:
 - o AIPs (NOTAMs), eTOD, AIXM, GIS* in development for 2009
 - Five letter name codes (5LNC)* in development for 2009
 - Reporting forms on certification of aerodromes, SMS certification and emergency plans*
 - o NDB equipment deactivation plan*
 - o Electronic Air Navigation Plan (eANP)* in development for 2009
 - Publication of the FASID Tables*
- Technical Co-operation Section:
 - o Training Directory
 - Fellowships procedures (for States who have a Technical Co-operation Project):
 - Fellowship forms
 - ICAO guide for fellows
- Aviation Security (AVSEC) Section *:
 - O Questionnaires and information on AVSEC threats* in development
 - Updated information on AVSEC events*
- Frequently asked questions (FAQ)

- 2.2 Considering the abovementioned and in order to achieve an optimum result, a State Letter Ref. NA 6-1.6.1, EMX0882 dated 14 August 2008, was sent inviting States/Territories/International Organizations to provide the following information no later than **10 October 2008**:
 - information that your State/Territory/International Organization considers important to include on the NACC Office website; and
 - links you want to be included.
- 2.3 The current website, whose domain is www.icao.int/nacc is intended to be kept in operation until the final release of the new website, whose domain will be www.mexico.icao.int, which can be visited starting on 8 September 2008. Both sites will work simultaneously, foreseeing operational readiness of the final version by the end of October 2008. The **Appendix** to this paper includes a snapshot of the new website design.
