H.E. Shiekh Mohammed bin Abdulla bin Mohammed Al Thani was appointed as Minister of Transport in November 2024. H.E. Shiekh Mohammed bin Abdulla bin Mohammed Al Thani has extensive experience in finance, governance, communications, and digital transformation. Earlier in his career, he was a senior officer at the Qatar Armed Forces (General Headquarters), then later was assigned to several leadership and executive positions in the Ooredoo Group such as Deputy Chief Executive Officer of Ooredoo Group, Chief Executive Officer of Ooredoo Qatar, Chief Executive Officer of Ooredoo Kuwait, Chairman of the Board of Directors of Ooredoo Oman, Ooredoo Kuwait, Ooredoo Myanmar and Ooredoo Algeria. His positions also included being the Vice Chairman of the Board of Directors of Asiaccell Iraq, President Commissioner of Indosat Ooredoo, Board Member of both INJAZ

Qatar and United Networks, and member of the Qatar Association of Certified Public Accountants. H.E. Shiekh Mohammed bin Abdulla bin Mohammed Al Thani holds a Master of Science in Accounting and Finance from Cardiff University, Wales, the UK, and a B.A. in Economics and Administrative Science, majored in accounting, from Qatar University. He also holds certifications from the Leadership Program for Executives from the Qatar Leadership Centre including courses by Harvard Business School and HEC Paris, and from the Intensive Executive Breakthrough Program by Egon Zehnder and Mobius Executive Leadership.

### H.E. Mohamed bin Faleh Al-Hajri, Acting President, Civil Aviation Authority, Qatar



He has held the position of In Charge of Managing QCAA in the State of Qatar since October 2021. With over 25 years of experience in air transport, international relations, and economic policy related to the aviation sector, he previously served as the Director of the Air Transport Department at the Authority.

His expertise includes international agreements, treaties, and protocols. He has represented the State of Qatar in numerous high-level international aviation forums and is an active member of various executive boards, expert committees, and technical working groups within the civil aviation sector.

## Mr. Salvatore Sciacchitano, President of the Council, International Civil Aviation Organization



Mr. Sciacchitano graduated in Telecommunications Engineering from the University of Catania and began his career in aviation in 1980, joining the Italian Airworthiness Authority (RAI) where he held positions of increasing responsibility, serving as the organization's Regulation Director in 1992, then as Technical Director and, in 1996, as Director General. With the merger of the aviation branch of the Ministry of Transport and RAI and the subsequent establishment of the Italian Civil Aviation Authority (ENAC), Mr. Sciacchitano assumed the position of Deputy Director General. In this position, he played an instrumental role in coordinating the core business divisions of the newly founded structure. He was also entrusted with multiple international mandates, chairing the Permanent

Commission of EUROCONTROL, representing Italy in the Management Board of European Aviation Safety Agency (EASA), holding the Vice-Presidency of the EUROCONTROL Provisional Council and coordinating the Italian delegation during ICAO Assemblies. As a result of his extensive experience in aviation international affairs, Mr. Sciacchitano was appointed Executive Secretary of the European Civil Aviation Conference (ECAC) in 2010. In February 2019, he joined the Italian Delegation on the Council of ICAO, where he served until assuming his duties as President of the Council.

## Setting the Scene

### Mr. Juan Carlos Salazar, Secretary General, ICAO



Mr. Juan Carlos Salazar is the Secretary General of the International Civil Aviation Organization (ICAO). He was first appointed for a three-year term starting August 2021. On 11 March 2024, the ICAO Council renewed his appointment for a second consecutive three-year term, to begin August 2024.

His career in international civil aviation spans over 30 years in various advisory and leadership roles. Prior to his appointment as Secretary General, Mr. Salazar served as Director General of Aeronautica Civil of Colombia – Aerocivil.

For the twelve years prior to joining Aerocivil, Mr. Salazar was a Senior Advisor to the UAE General Civil Aviation Authority. His professional experience also includes terms as the President of Latin American Civil Aviation Commission (LACAC), Secretary of the Colombian Civil Aviation Board and Director of its Air Transport Office, Director General of Air Transport at the Colombian Ministry of Transport, Corporate Secretary and Director of the Legal Department of Tampa Cargo (currently known as Avianca Cargo). Mr. Salazar is a lawyer and has earned advanced degrees from Harvard University (Master in Public Administration - MPA) and McGill University (Master in Air and Space Law - LLM), and was awarded an Honorary Doctorate degree in Law from Korea Aerospace University. He is fluent in Spanish, English and French, and speaks basic Arabic.

**Mr. Mohamed Khalifa Rahma**, Director, Air Transport Bureau, International Civil Aviation Organization (ICAO)



Mr. Mohamed Khalifa Rahma assumed his position as Director, Air Transport Bureau, of the International Civil Aviation Organization (ICAO) in April 2020. Before his appointment, Mr. Rahma was the Regional Director of the ICAO Middle East Regional Office since March 2016. The current work portfolio of Mr. Rahma covers a wide range of global aviation domain including Air Transport, Aviation Security and Facilitation and Environmental protection. He is currently the Secretary of the Council Aviation Recovery Task Force (CART). During his tenure in ICAO Middle East Office, he was instrumental in strengthening regional and inter-regional collaboration in aviation industry. This effort included enhancing risk awareness and response, promoting technologies while fostering new innovations, and improving oversight and quality assurance. Mr. Rahma continues to significantly increase cooperation among member States, international and Regional organizations. Prior to Joining ICAO, Mr. Rahma was the Undersecretary of International and Internal Affairs at the Ministry of Civil Aviation of Egypt and previously the advisor to the Egyptian Minister of Civil Aviation. During his tenure at the Egyptian government, Mr. Rahma played a substantial role and led influential projects that actively supported and enhanced aviation capacity and efficiency in Egypt. He developed cooperative relationships with government bodies and investors while paving the way for future business partnerships and opportunities. Mr. Rahma was a board member of various companies including Cairo Airport Company, Aerotel Company and EMAC Aqaba Company and chaired many strategic committees under the umbrella of the Ministry of Civil Aviation for special projects. He led and participated in many high level national and regional committees. Mr. Rahma has 30 years of aviation experience in various fields including aviation management, airline management, operation, safety, training, corporate communication, and crisis management. He holds a Master's Degree in Aviation Management and speaks fluent English and Arabic.

**Mr. Willie Walsh**, Director General, International Air Transport Association (IATA)



Willie Walsh became the eighth person to lead the International Air Transport Association (IATA) when he took on the role of Director General in April 2021.

Prior to joining IATA, Walsh spent his entire career in the airline industry, beginning as a cadet pilot with Aer Lingus in 1979 and rising to the position of Chief Executive at the airline in 2001. In 2005 he was appointed Chief Executive of British Airways (BA). He led BA through the 2008/09 global financial crisis, established a transatlantic joint business venture with Iberia, Finnair and American Airlines, and oversaw the 2011 merger of BA and Iberia under a newly established parent company, International Airlines Group (IAG). He was Chief Executive of IAG from its inception until September 2020.

Under Walsh's leadership, IATA has focused on supporting the industry's emergence from the COVID-19 crisis as well as aviation's ambitious and historic commitment to achieve net zero carbon emissions by 2050. Walsh has also advocated for infrastructure partners to avoid recouping their COVID losses from their customers including airlines and air travelers.

Walsh is deeply familiar with IATA, having also served on the IATA Board of Governors between 2005 to 2018, including serving as Chair (2016-2017). A citizen of Ireland, Walsh was born in Dublin, Ireland, in 1961. Walsh holds a Master of Science and Business Administration from Trinity College, Dublin.

### **Ms. Poppy Khoza, Director, South African Civil Aviation Authority (SACAA)**



Ms Poppy Khoza is the Director of Civil Aviation (DG) at the South African Civil Aviation Authority having been re-appointed by the South African Government for a third successive five-year term that began on 1 December 2023. Among her leadership accomplishments, Ms Khoza has chaired two ICAO panels – the Aviation Security and the High-Level Conference on the Covid-19 pandemic. She was later elected President of the 2022 ICAO General Assembly where she, historically, became the first woman to preside over an Assembly since the formation of ICAO in 1944. Ms Khoza is a recipient of many accolades that include the 2023 IATA Inspirational Role Model Award - Diversity and Inclusion Awards, the Aviation Sector and Regional Leader Award, Best

Chief Executive Officer Awards, Top Empowered Business Leader, Public Service Leader of the year, as well as South Africa's Most Influential Woman in Business and Government in the Agencies and Regulatory Authorities. She was also the first recipient of the Flight Safety Foundation's Gloria Heath Award that recognises notable woman achievements in civil aviation as well as Ms Khoza's leadership towards promoting gender diversity in international aviation. The African Civil Aviation Commission (AFCAC) and the AFI group also honoured her with an accolade to acknowledge her contribution towards the development of civil aviation in Africa. Ms Khoza is a passionate advocate for gender equality in the aviation industry globally. She has championed the transformation of the SACAA that now boasts a 51% make-up of female employees and a 50% make-up of capable women serving in Executive Management positions. In collaboration with ICAO, UNESCO and the United Nations Women, Ms Khoza was instrumental in the concept and implementation of the first-ever Global Aviation Gender Summit that was hosted in August 2018 in South Africa. Under her stewardship, the SACAA scooped the Best Performing Institution in Transport Award on four (4) occasions, while the entity achieved eleven (11) clean audits over 12 financial years from the office of the Auditor-General South Africa for good corporate governance. The SACAA was also honoured as a Top Performing Public Service Award where they were recognised for investing in People; a recipient of an award as a Transformation Champion and have received certification as a Top Employer by the Top Employer Institute for exemplary human resources programmes.

### **Mr. Olivier Onidi, Deputy Director General, DG Home Affairs, European Commission**



Since May 2016, Olivier Onidi is Deputy Director-General of the Directorate-General for Migration and Home Affairs (DG HOME) at the European Commission with particular responsibility over Schengen and Internal Security. In this capacity, he oversees the activities in the fields of Schengen, borders, information systems, innovation, terrorism and violent extremism, organized crime and cybersecurity. He also led the European Commission's Task Force for the Security Union and held respectively the EU Anti-Trafficking Coordinator and Counter-Terrorism Coordinator positions. Since July 2022, Olivier Onidi is also the EU Schengen Coordinator. Olivier Onidi's last assignment was Deputy Director-General of DG HOME with the specific task to coordinate the Commission-wide work in the context of the refugees' crisis 2015-2016. Previously, he was Director for the European Mobility Network within the Directorate-General for Mobility and Transport, responsible for the development of

the Trans-European Transport Network infrastructure, the implementation of the Connecting Europe Facility funding instrument, the creation of a Single European Rail Area and policy around ports. Prior to this, he was Director for Innovative and Sustainable Mobility in charge of transport security, clean and urban transport, intelligent transport systems and road safety.

Olivier Onidi also worked as Deputy Head of Cabinet of the Energy Commissioner, Mr Günther H. Oettinger, as Head of Unit for air transport services, aviation safety and environment and was Head of the Satellite Navigation System programme - GALILEO. His first posts in the Commission were Assistant to Directors-General in the areas of Energy and Transport and External Relations. He then moved to the Secretariat General and afterwards became Member of Cabinet of the Commissioner for Research and Development, Innovation, Education and Training. Before joining the Commission, Olivier Onidi worked as Adviser to the Executive Committee of Belgacom and as Public Policy Manager at American Express International. Olivier Onidi holds Master degrees in International Economics, European Studies and Business Administration. He has French citizenship.

### **Mr. Essa Al-Malki, Representative of Qatar on the Council of ICAO & Chairperson, ICAO Air Transport Committee**



Mr. Essa Al-Malki serves as the Representative of the State of Qatar on the Council since October 2022 and was appointed as the Permanent Representative of the State of Qatar to ICAO since June 2017 when he was entrusted with the establishment of the first Permanent Office of the State of Qatar to ICAO. During his term as Permanent Representative, the ICAO-Qatar relations have been greatly strengthened. Mr. Al-Malki has been instrumental in enhancing Qatar's collaboration with ICAO throughout the years. Prior to his assignment to ICAO, he has served in several leadership roles at the Qatar Civil Aviation Authority (QCAA) as a legal expert, before assuming the senior position of the Head of the Air Transport Agreement Section. During his tenure, Mr. Al-Malki was responsible for the negotiation and grant of traffic rights for the National Carrier

Qatar Airways, as an experienced international negotiator for Air Transport Agreements between the State of Qatar and other states. Besides his robust knowledge of the aviation industry, with expertise in negotiation, management, and protocol, his participation in ICAO's work has further enriched his expertise and global perspective. He served as chair of the ICAO's Technical Co-operation and Implementation Support Committee (TCC), between 2023 and 2024 and is currently chair of the Air Transport Committee (ATC) for years 2024-2025. Undertaking these roles reflects the international community's recognition of Qatar's leadership in civil aviation as well as its active participation in addressing global challenges. Mr. Al-Malki, holder of a bachelor's degree in political and legal Studies from the Indiana State University, USA (2012) and a master's degree from Hamad Bin Khalifa University in Qatar, brings a wealth of professional excellence to his role, marking a distinguished career in aviation and diplomatic representation. Through his leadership and dedication, Mr. Al-Malki aims to continue to strengthen Qatar's position as an active partner in the international civil aviation community and advance its role in global aviation, while addressing evolving challenges and responding to the rapid developments in civil aviation.

She has held leading change management posts in organizations and is the first woman to be Iceland's Representative on the Council of ICAO. From October 2019, Ms. Aðalsteinsdóttir has been a part of the NORDICAO rotation group and served as Alternate Representative of the Republic of Finland on the Council until 1 October 2022 when she became the Representative of Iceland on the Council of ICAO.

From 2004 until her appointment as Alternate Representative on the Council of ICAO she held various positions in the Icelandic Civil Aviation Authority (now the Icelandic Transport Authority – ICETRA). Among her professional experience, Ms. Aðalsteinsdóttir has served as ICAA's Public Relations Manager, Manager Special Projects, Director

Customer Service Division as well as being a member of ICETRA's Executive team. She was Iceland's Aviation Council's Secretary for seven years and around ten years of experience with Icelandair in various positions from ground handling to Project Manager. Ms. Aðalsteinsdóttir is a Bachelor of Art graduate in sociology from the University of Iceland and has two Diplomas in Human Resource Management and Public Administration. She has taken part in various seminars regarding management training, change management, public and information rights, management systems, human factor and human relations, quality and risk-based management, as well as internal and external audits. During Ms. Aðalsteinsdóttir's vast experience in the field, she has gained general knowledge of international aviation cooperation and of ICAO's Council's procedures. Ms. Aðalsteinsdóttir was nominated for Stjórnvísir 2019, Icelandic Management Award. Ms. Aðalsteinsdóttir remains strongly committed to support ICAO's work and to promote a safe, secure and sustainable civil aviation in a transparent and efficient way. Her role is to promote Safety, Security, Air Transport Liberalization, Environmental protection and overall sustainability of the African Air Transport sector across the continent. In November 2024, during AFCAC's 35th Plenary Ordinary Session, she was re-elected for another three-year term, reaffirming her exemplary leadership and commitment to advancing African civil aviation. With an international career spanning over 25 years, Adefunke has been recognized as one of the 100 Most Inspirational African Women. She was also honoured as one of the 200 globally Most Influential People of African Descent (MIPAD) in affiliation with the United Nations Decade for People of African Descent. She is also the 2021 Recipient of the Ato Girma Wake Lifetime Achievement Award for Services to African Air Transport and Trade development. She studied Law at the University of Lagos, Nigeria and qualified as a Barrister and Solicitor of the Nigerian Supreme Court in 1998, holds a Master of Laws (LL.M.) from the prestigious University of Cambridge, United Kingdom and a Master of Business Administration (MBA) from Nanyang Business School, Singapore in collaboration with Wharton Business School, Philadelphia and Berkeley Hass Business School, California.

He has served as a university professor in subjects related to public policy, public management, negotiation, and air transport law. Since January 2019, he has served as Secretary of the Latin American Civil Aviation Commission (LACAC). He has over 22 years of experience in the public sector, particularly in land and air transport. He has held positions as Counselor and later as Secretary General of the Civil Aviation Board of the Ministry of Transport and Telecommunications of Chile. He also served as Director of the State Railways Company (EFE-Chile) and the Arica-La Paz Railway Company (FCALP-Chile), as well as Executive Director of the Land Transport Inspection Program of the Undersecretariat of Transport of Chile. In the course of his duties, he has led international negotiations,



promoted liberalization and facilitation processes in commercial air transport, and organized seminars, courses, and workshops both nationally and internationally on aviation-related topics. In his role at LACAC, he actively promotes cooperation among 22 States from Latin America and the Caribbean, fostering regional integration in civil aviation.

Mr. Nari Williams-Singh joined the Jamaica Civil Aviation Authority (JCAA) in 1997 as an Aviation Safety Inspector – Airworthiness/Avionics, having previously studied in Toronto, Canada and worked in both Canada and Jamaica in the field of aircraft maintenance. He has amassed a wealth of experience in the air transport industry, in aircraft maintenance, safety and security oversight, provision of air navigation services, and civil aviation administration. His successful career at the JCAA has spanned various assignments of progressive responsibility, with appointments as Manager – Airworthiness; Director - Flight Safety; Deputy Director General – Regulatory Affairs and Director General. Mr. Williams- Singh has held the position of Director General of the Jamaica Civil Aviation Authority (JCAA) since October 2014. He serves on the Boards of the JCAA, AEROTEL Limited (a subsidiary of the JCAA) and is currently the Chairman of the Board of Directors of the Caribbean Aviation Safety and Security Oversight System (CASSOS). Mr. Williams-Singh's was elected and served as President of the International Civil Aviation Organisation's (ICAO) (40th) General Assembly in 2019. In 2022 Jamaica was elected to the Council of ICAO and Mr. Williams-Singh has been a Member of the Delegation representing Jamaica on the ICAO Council for the 2022-2025 triennium.

### **Mr. Douglas Yeo, Director, Security Policy & Emergency Preparedness, International Relations and Security Division, Ministry of Transport, Singapore, Chairperson, Facilitation Panel (FALP)**



Douglas Yeo is the Director for Security Policy and Emergency Preparedness with the Ministry of Transport, Singapore. His team oversees all aspects of Land, Air and Maritime transport security policies, including cybersecurity and emergency preparedness. Prior to joining the Ministry, Douglas served as the Deputy Director for Aviation Security and Emergency Preparedness with the Civil Aviation Authority of Singapore, as well as with the Singapore Police Force. In his 20 years of service with the Singapore Police Force, Douglas saw duty in a range of roles spanning command, investigations and operations in various police units. Douglas left the Singapore Police Force with the rank of Superintendent of Police and was at that time in-charge of aviation security and quality control with the Airport Police Division. Douglas led Singapore's effort in developing and implementing an air cargo supply chain security regime. He was also instrumental in developing and implementing Singapore's national civil aviation security quality control programme, as well as fronting Singapore's compliance efforts for the Universal Security Audit Programme conducted by the International Civil Aviation Organisation in 2006, 2012, and 2023. Douglas is the Chair of the ICAO Facilitation Panel, as well as Singapore's representative on the Panel. He is also Singapore's alternate representative for the ICAO Aviation Security Panel, and Vice-Chair of the ICAO Asia and Pacific Regional Aviation Security Coordination Forum (RASCF). Douglas was chair of the Aviation Security & Facilitation sub-group of the ICAO APAC COVID-19 Contingency and Recovery Planning Group. He has also been the Rapporteur of the ICAO Facilitation Panel's Working Group on Guidance Material since 2016. Douglas graduated in 1993 with an Honours degree in Economics and holds professional qualifications as an Avsec Professional Manager, ICAO Certified AVSEC Instructor and ICAO Certified USAP-CMA Auditor.

Mr. Ángel-Luis Arias is the Representative of Spain on the ICAO Council since June 2023. Before ICAO Council and since 2015, Mr. Arias was the Director General of ENAIRE, the Spanish ANSP and President of CRIDA, a company dedicated to the research and development of innovative solutions in air traffic management (ATM). Since 2012, Mr. Arias held the positions of Director General of Civil Aviation (DGAC) and Chairman of the Aviation Safety and Security Agency of Spain (AESA) and Vice-President of the European Agency for the Safety of Air Navigation (EUROCONTROL). Mr. Arias also worked at AENA, the National Spanish Airport Operator, occupying diverse technical and managerial positions. Before joining AENA, he worked as officer in the Spanish Air Force. Mr. Arias holds Master's degrees in Aeronautical Engineering and in Business Administration.

President of the Association of People Affected by Flight JK5022 since 2010. Chairwoman of Air Crash Victims Families' Federation International, which she founded in Madrid in 2015, with the Associations of Germany and Pakistan. ACVFFI was recognized by the ICAO Council in 2016 as the first Organization to bring together victims and families of air accidents. Founder and President of the A20 Aviation Safety Foundation, created in 2023 to collect the legacy of her advocacy at the head of previous Organizations and ensure their continuity. Since 2010 she has participated at ICAO with important achievements; the approval of ICAO Victim and Family Assistance Policy Document 9998 and its inclusion as a recommendation and then as a standard in Annex 9, in the

USOAP Program; the Manual 9973; the Declaration of February 20 as the International Day of Victims and Families of Air Accidents; Ensuring planning of Symposia every 3 years (2021 and 2024) dedicated to promoting dialogue between victims and families with industry, States, airports, airlines, media, insurers, etc..., to propose lessons learned and their solutions. She has participated as speaker in numerous national, European and international events, carrying the message of the lessons learned in air disasters to improve management in emergencies and avoid additional suffering to people who suffer them in the future. She works in "the memory of those who died in air accidents for the safety of aviation users-professionals".

**Ms. Aysha Al Hamili, Assistant Director General, Air Accident Investigations Sector, United Arab Emirates (UAE)**



Captain Aysha Al Hamili was appointed Assistant Director General –Air Accident Investigation Sector (AAIS) in April 2021, the sole authority of air accident investigations in the UAE. Since then, she has introduced many strategies to position the AAIS within the top organizations globally. Al Hamili made history at 16 by becoming the first female pilot in the UAE in 1998. This achievement set the stage for her future success in the aviation industry. Alhamilibroke the record for being the youngest Permanent Representative in ICAO Council throughout the organization's history. Her tenure at the ICAO spanned over a decade (2009-2020). She led several panels, committees, task forces, and working groups to

establish new ICAO strategies and improve the existing ones. Before that, Al Hamili established the Air Transport Department, where she led more than 80 bilateral and multilateral agreements for three years. Her first post at the GCAA was as Air Accidents and Regulations Senior Officer. In 2019 She was awarded an Honorary Doctorate Degree from AgeanUniversity (Greece) for her contributions to the world air transport, Air and Space law post-graduate certificate from McGill (Canada), a Master's in Air Transport Management from City University (London), a Bachelor of Social and Behavioral Sciences from Zayed University (UAE). In addition, she holds CPL and ATPL from the UAE and Jordan.

## Mr. Albert Urdiroz, Deputy Head of Accident Investigations and Prevention, Airbus Commercial Aircraft

He has developed internal and external investigation training. Albert Urdiroz represents the manufacturers and service providers at the ICAO AIGP, the accident investigation panel, as a member of the ASD and of the ICCAIA, respectively the Aerospace, Security and Defence Industries Association of Europe and the International Organization for Aerospace Industry Associations.

## Session 10 Passenger Data Systems

## Session 11 Accessibility in International Civil Aviation

### Dr. Olumuyiwa Benard Aliu, Lifetime Goodwill Ambassador of ICAO



Dr. Olumuyiwa Benard Aliu is the founder and President of the International Partners for Aviation Development, Innovation and Sustainability (iPADIS). iPADIS partners with governments, global and regional organizations, industry and civil society stakeholders to promote innovative, inclusive and sustainable development of international civil aviation and its contribution to peace, economic prosperity and social progress around the world. Prior to this, Dr. Aliu was the fifth President of the Council of the International Civil Aviation Organisation (ICAO) from January 2014 to December 2019. Upon completion of his term of office he was named Lifetime Goodwill Ambassador of ICAO, and the ICAO Museum was named after him as ‘*Olumuyiwa Benard Aliu Museum*’. Dr Aliu has also been bestowed with numerous international honours and awards for his many notable accomplishments including the Nigeria’s National Honour, Commander of the Order of the Federal Republic (CFR) and the renaming of the Akure Airport, in Nigeria as "Olumuyiwa Bernard Aliu Airport, Akure". Dr. Aliu’s extensive professional experience in civil aviation spans over 40 years. He was the Permanent Representative of Nigeria on the Council of ICAO from January 2005 until end of 2013. He also served Nigeria in various positions of increasing responsibility in the areas of safety oversight, economic regulation and negotiations of bilateral and multilateral agreements, including as Chief Airworthiness Surveyor, Director Air Transport Regulation and Technical Adviser to the Minister of Aviation. Dr. Aliu graduated in 1983 with MSc. Degree in Aeronautical Engineering from the National Aviation University, Kiev, and further obtained a PhD in 1987. He holds an Aircraft Maintenance Engineer’s Licence, an IATA Diploma in Civil Aviation Management as well as a Graduate Certificate in Air and Space Law from McGill University, Canada. ## Mr. Roberto Castiglioni, Director, Reduced Mobility Rights Ltd., London

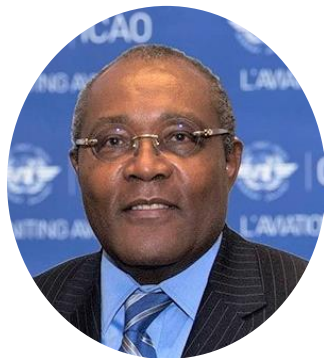

## Session 12 Maintaining Health and Sustaining Safe International Air Transport During Public Health Emergencies of International Concern Affecting Air Travel

## Mr. Soonil Hwang, Deputy Director Fast Travel Team, Incheon International Airport Corporation (IIAC)



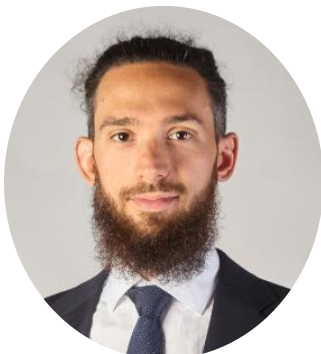
