## Chicago Convention: FAL articles



- Art. 10: Aircraft to land at designated *customs* airport for customs & other examination
- Art. 11: *Aircraft* to comply with laws on *entry/departure & within* a State
- Art. 13: Passengers, crew, cargo: compliance with laws on *entry, clearance, immigration, passports, customs, quarantine*
- Art. 14: State to take measures to prevent the *spread of disease*



## Chicago Convention: FAL articles cont.



- Art. 22: State to take measures:
  - expedite navigation by aircraft;
  - prevent unnecessary delays to aircraft, pax., crew, cargo in admn. of I, Q, C & Clearance formalities
  
- Art. 23: State to establish C & I procedures in accordance with practices recommended (by ICAO)
  
- Art. 29: Documents carried in aircraft: passenger manifest, cargo manifest
  
- Art. 37(j); Art. 38



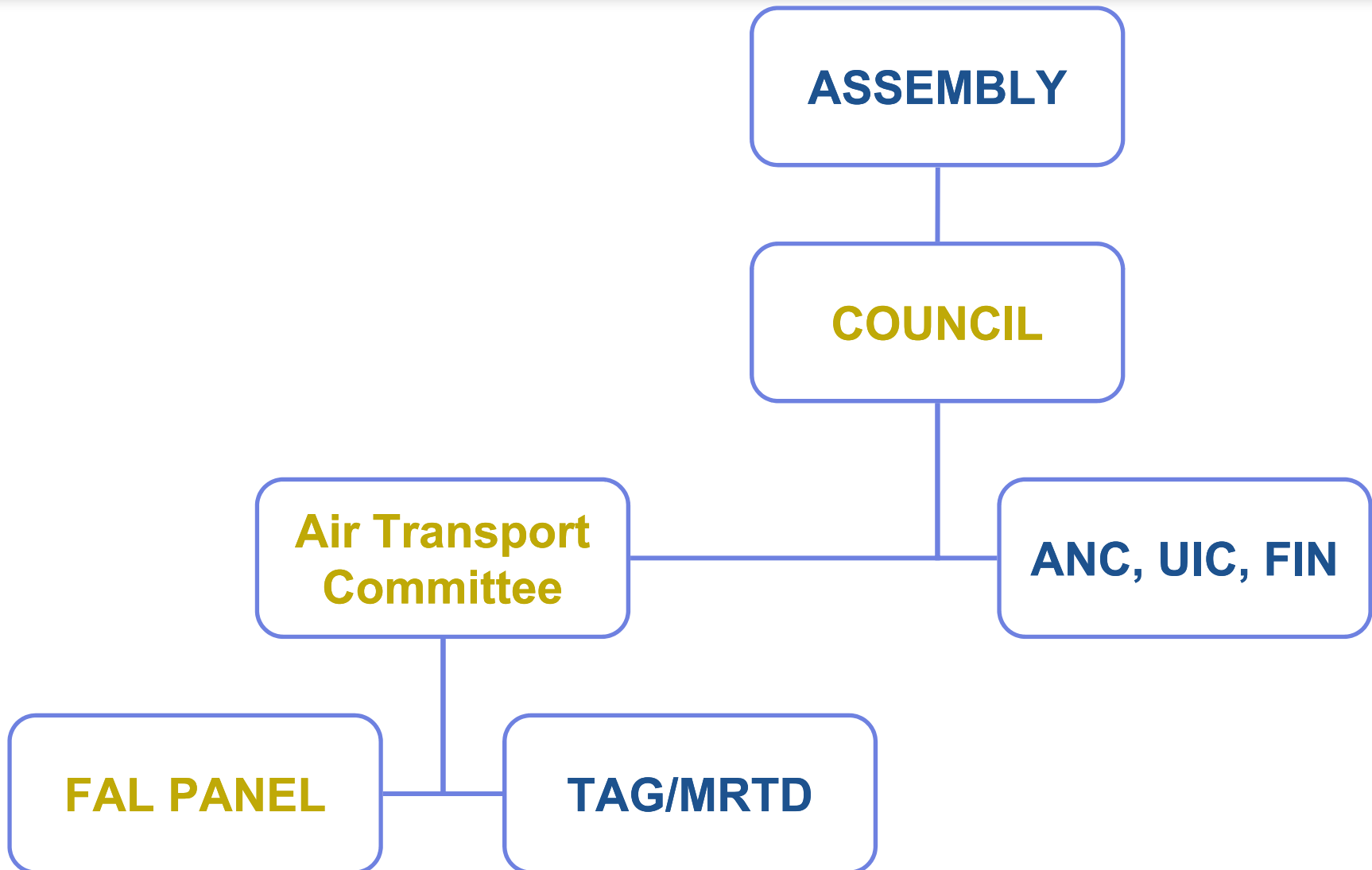
## Annex 9: SARPs



- Annex 9-Facilitation of international air transport
- STANDARD: Any specification, the uniform observance of which is necessary to facilitate air navigation and non-compliance must be notified under Article 38
- RP: Any specification, the uniform observance of which is highly desirable to facilitate air navigation and to which States will endeavour to conform

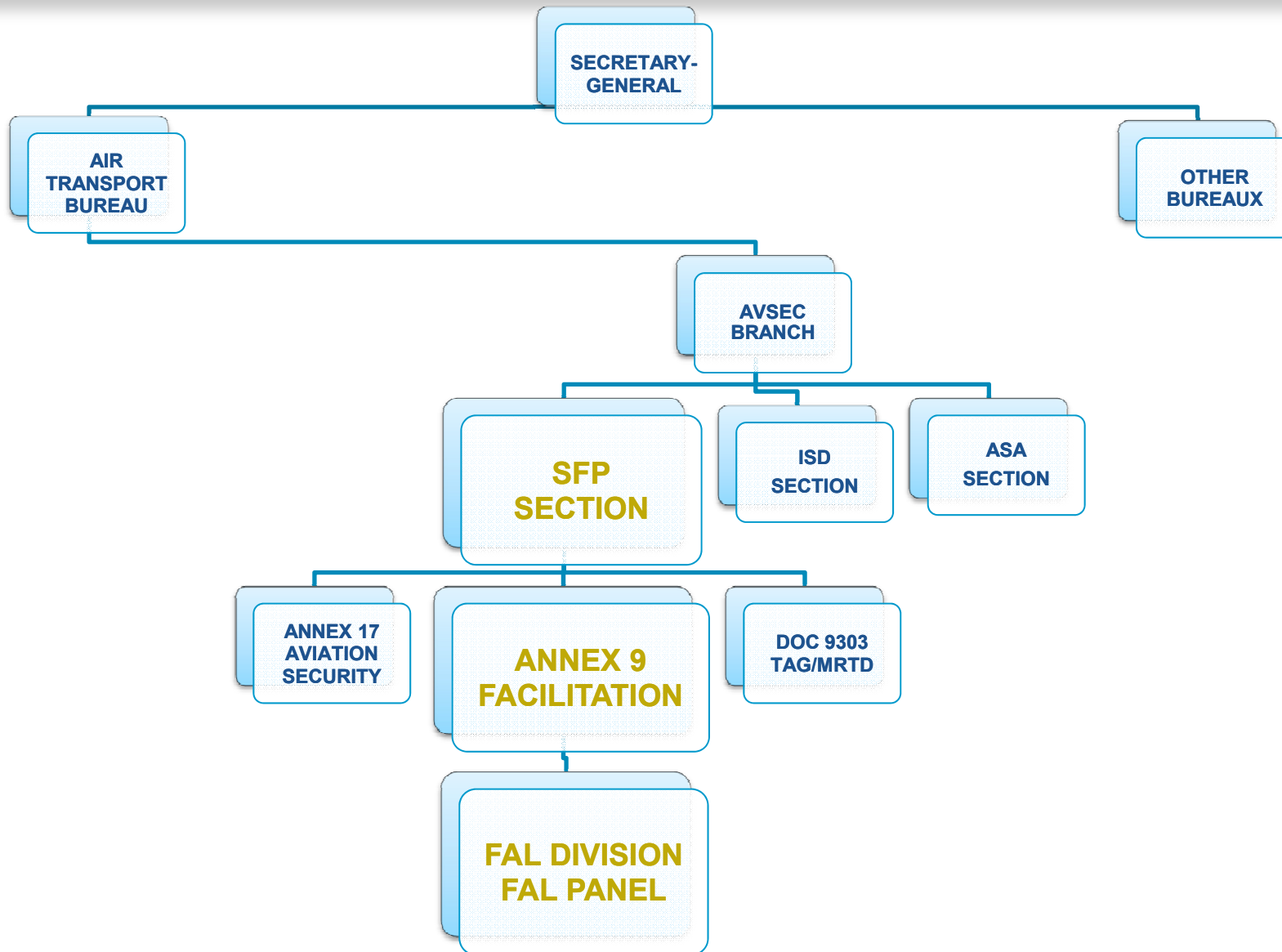


# ICAO Structure



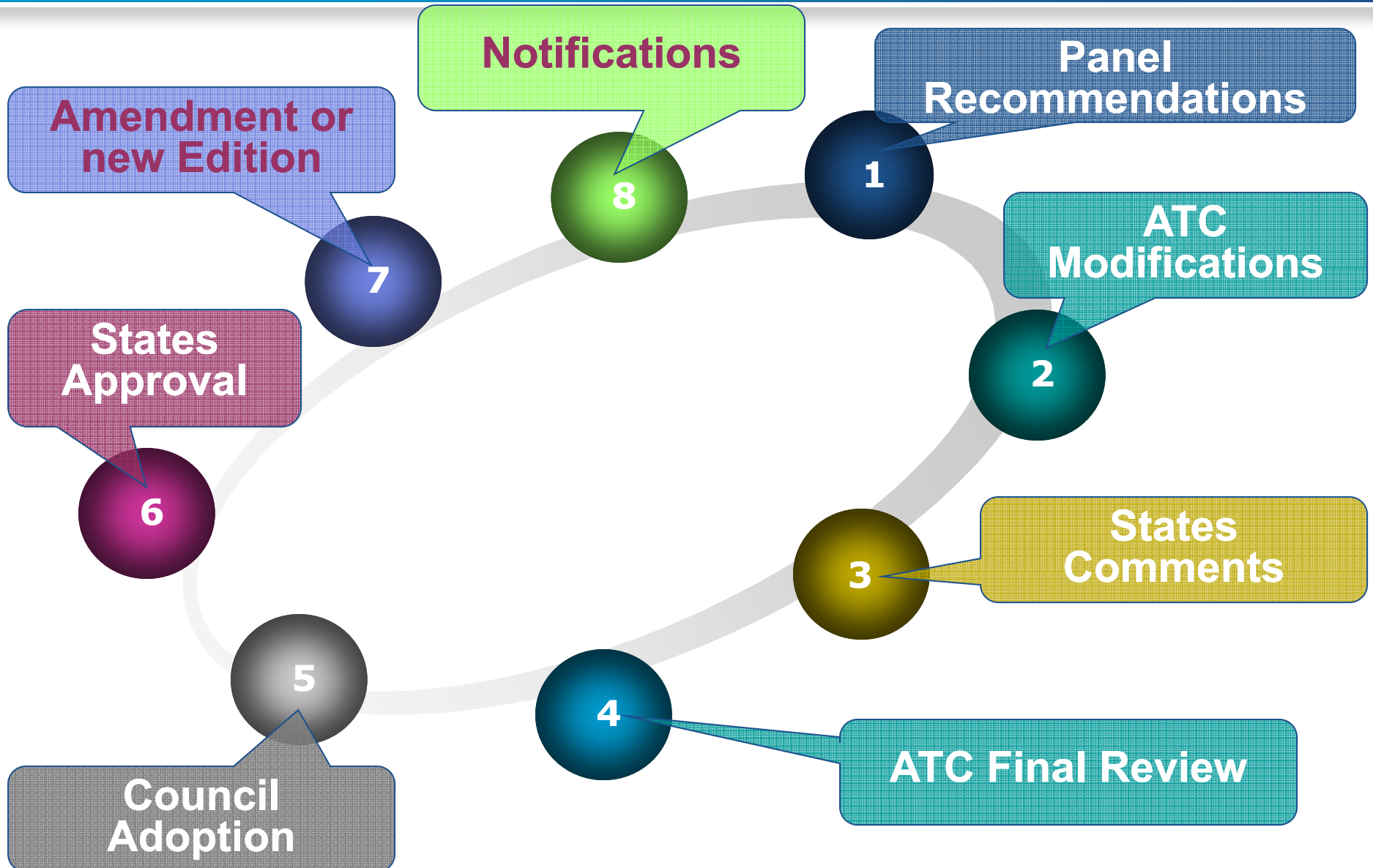

# Annex amendment process





## Timeline for Amendment 22



- June 2010: ATC: FALP/6 report
- July 2010: State letter with proposals
- Oct/Nov 2010: Deadline for responses
- January 2011: ATC final review
- Jan/Feb 2011: Council Adoption
- June 2011: Deadline for disapprovals
- July 2011: Amendment becomes effective
- Sept/Oct 2011: Amendment 22 applicable
